Nairobi Work program is important

The issues to be considered by NAP and other efforts outside convention as well such as CBD and SFA

Under the UNFCCC Koronivia discussion has proven to be firmly engage in developing understandings regarding agriculture as a particular vulnerable sector, majorly responsible to deliver food security to a very uneven and still very unequal world

Guided by the UNFCCC discussions on issues related to agriculture, in Brazil the ABC Plan improved public awareness regarding climate change and how agriculture could play a major role in face of the expected challenges

The Koronivia JWP, the NWP, and Research Dialogue

The key factor is, that the UNFCCC has created the international framing and the enabling environment with discussions on issues related to agriculture and more recently with the Koronivia discussions

UNFCCC constituted-bodies to form a single task force to work on land/CCA issues

Focus on inviting stakeholders that usually are not heard to share their views.

Use experiences and tools on ecosystem-based adaptation, e.g. CBD voluntary guidelines, to create linkages between land and environment, e.g on ecosystem restoration

Create strong synergies between NDC update + implementation, NAP process and also Post 2020 Global Biodiversity Framework. All NBSAP, National Biodiv Action Plans, have to be updated after CBD COP next year!

According to NDC Partnership, 97% of countries plan to enhance ambition on adaptation in their updated NDC. We need to create synergies with NAP, NBSAP, Sendai targets, Agriculture policies etc esp. on land degradation and restoration.

Believe that actions only under UNFCCC/PA are important but also outside, for instance CBD, FAO, UNEA etc

AFOLU is the sector with strongest links between mitigation and ecosystem-based adaptation EbA as a type of nature-based solutions NbS, also also links to UNCCD. Use UN Decade on Ecosstem Restoration 2021-2030 to highlight this!

Increase funding for concrete implementation on the ground and ensure coordination and cooperation across frameworks.

CBD can help on restoration of biodiversity richness and resilience to climate change that can complement land and ecosystem based adaptation.

ICC to adopt ecocide as crime. IPCC findings, including to the SRCCL, to be a more accessible and practical in relation to regional farming communities. Need to strengthen joint action frameworks with CCD and CBD among others

Next year the 3 Rio Conventions (UNFCCC, CBD, UNCCD) will hold their Conference of the Parties. This represents an excellent opportunity to create synergies on land and climate related matters

developing analysis tool combining biodiversity, combating desertification, and climate change with clear indicators to set up planning and actions
