<sup>1</sup> President of COP 30/CMP 20/CMA 7, was elected at the opening of COP 30 on Monday, 10 November 2025.<sup>2</sup> Pending nomination from COP 29<sup>3</sup> Ms. Carol Franco was re-elected as Vice-Chair SBSTA at the third meeting (closing plenary) of the SBSTA on Saturday, 15 November 2025.<sup>4</sup> Ms. Rita Mishan (Guatemala) was elected as SBSTA Rapporteur at the third meeting (closing plenary) of SBSTA on Thursday, 26 June 2025.<sup>5</sup> Mr. Eiyad Aljubran (Kingdom of Saudi Arabia) was elected as SBI Vice-Chair at the third meeting (closing plenary) of SBI on Thursday, 26 June 2025.<sup>6</sup> Ms. Kamil Salazar (Belize) was elected as SBI Rapporteur at the third meeting (closing plenary) of SBI on Thursday, 26 June 2025.<sup>7</sup> The Chair of GRULAC informed the secretariat that GRULAC has agreed on a seat sharing formula for the position of Vice-President on the Bureau as follows: Ms. Sara Gonzalez (Dominican Republic) will serve as Vice-President for SB 64, and Mr. Juan Carlos Monterrey (Panama) will serve as Vice-President for COP 31/CMP 21/CMA 8.<sup>8</sup> The Chair of the Asia Pacific Group informed the secretariat on 22 November 2025 that APG has agreed on a seat sharing arrangement for the position of member as follows: Ms. Eunhae Jeong (Republic of Korea) in 2026 and Mr. Mohammed AlNahas (Kingdom of Saudi Arabia) in 2027.<sup>9</sup> The Chair of the Asia Pacific Group informed the secretariat on 22 November 2025 that APG has agreed on a seat sharing arrangement for the position of alternate member as follows: Mr. Mohammed AlNahas (Kingdom of Saudi Arabia) in 2026 and Mr. Ahmed Masoon Hassan (Maldives) in 2027.<sup>10</sup> The Chair of the Asia Pacific Group informed the secretariat on 22 November 2025 that APG has agreed on a seat sharing arrangement for the position of member as follows: Mr. Mohammad Ayoub (Kingdom of Saudi Arabia) in 2026 and Mr. Do Ik Kim (Republic of Korea) in 2027.<sup>11</sup> The Chair of the Asia Pacific Group informed the secretariat on 22 November 2025 that APG has agreed on a seat sharing arrangement for the position of member as follows: Mr. Yolando Velasco (Philippines) in 2026 and Mr. Ali Waqas Malik (Pakistan) in 2027.<sup>12</sup> The Chair of GRULAC informed the secretariat on 21 November 2025 that GRULAC has agreed on a seat sharing formula for the positions on the PAICC as follows: A. Chile (Mr. Eduardo Silva Beza) will serve as a member for the first 3-year term and would be eligible for re-election, if he wishes, in accordance with GRULAC practice. B. Peru (Mr. José Félix Pinto-Bazurco Barandiarán) will serve as alternate for the first 3-year term. Peru will not seek re-election. Instead, Cuba will assume the alternate seat for the next 3-year term.<sup>13</sup> The Chair of GRULAC informed the secretariat that GRULAC has agreed on a seat sharing formula for this position on the CGE as follows: Mr. Federico Grullon de la Cruz (Dominican Republic) will serve only for one year (2026). Mr. Marcelo Rocha (Brazil) will serve as a Member for 2027.<sup>14</sup> The Chair of GRULAC informed the secretariat that GRULAC has agreed on a seat sharing formula for this position on the AFB as follows: 2026-2027: Panama (Ms. Ana Aguilar) will serve as a member and Cuba (Mr. Pedro Julio Ruiz Hernández) will serve alternate. For the years 2028-2029: Uruguay (Mariana Kasprzyk) will serve as a member and Cuba (Mr. Pedro Julio Ruiz Hernández) will serve as alternate.<sup>15</sup> The Chair of GRULAC informed the secretariat that GRULAC has agreed on a seat sharing formula for this position on the Article 6.4 Supervisory Body as follows: 2026: Colombia (Ms. Adriana Gutierrez), 2027: Dominican Republic (Ms. Luz Alcantara) and 2028: Honduras (Mr. Eduardo Ries).<sup>16</sup> The Chair of GRULAC informed the secretariat that GRULAC has agreed on a seat sharing formula for this position on the Adaptation Committee as follows: Mr. Eddy Frank Vásquez (Dominican Republic) will serve as a member for 2026 and 2027. Dominican Republic will not seek reelection, and Colombia will seek election for 2028.<sup>17</sup> The Chair of GRULAC informed the secretariat that GRULAC has agreed on a seat sharing formula for this position on the Adaptation Committee as follows: Ms. Angela Rivera (Colombia) will serve as a member for 2026 and Chile will serve as a member for 2027. Chile can be re-elected as a member of the Adaptation Committee.<sup>18</sup> The Chair of GRULAC informed that Uruguay will serve as a member on the Santiago Network Advisory Board for the year 2026 only.<sup>19</sup> The Coordinator of the Non-Annex I Parties informed the secretariat that the Non-Annex I Parties have agreed on a seat sharing formula as follows: the AFB seat will be split between Mr. Victor Vinas (Dominican Republic) and Mr. Oday Hadi (Iraq). Mr. Vinas will be taking the first year, followed by Mr. Hadi.<sup>20</sup> The Coordinator of the Non-Annex I Parties informed the secretariat on 28 November 2025 that the Non-Annex I Parties have agreed on a seat sharing formula as follows: the SCF seat will be split between Mr. Ali Waqas (Pakistan) and Mr. Abdiel Douglas (Panama). The first year will be taken by Mr. Waqas with Mr. Douglas replacing him at the end of 2026.<sup>21</sup> Non-Annex I Parties have agreed on a seat sharing formula for this Non-Annex I Parties' position on the Adaptation Committee as follows: for 2026, China will serve as member and for 2027, the Philippines.<sup>22</sup> Regional group or constituency to confirm initial 2-year or 3-year term of office.
