## MESSAGE TO NON-GOVERNMENTAL ORGANIZATIONS

### Invitation to the third global dialogue and the third investment-focused event under the Sharm el-Sheikh mitigation ambition and implementation work programme

27 – 29 May 2024

On behalf of the co-chairs of the Sharm el-Sheikh mitigation ambition and implementation work programme, Amr Osama Abdel-Aziz and Lola Vallejo, I am pleased to invite constituencies of admitted non-governmental organizations (NGOs), to participate in the third global dialogue and the third investment-focused event under the work programme.

The third global dialogue and investment-focused event is being organized pursuant to decision 4/CMA.4, by which the CMA decided that at least two global dialogues shall be held each year as part of the work programme and requested the secretariat to organize those dialogues under the guidance of the co-chairs of the work programme and will take place in Bonn, Germany from **27 - 29 May 2024** in a hybrid format. A full-day session is planned for 27 May and two half-day sessions are planned on 28 and 29 May.

Pursuant to the same decision, the co-chairs of the work programme have selected the topics “Cities: buildings and urban systems” to be discussed at each dialogue in 2024.

#### Nomination and registration details

Representatives of admitted NGOs nominated by constituency focal points (CFPs) must register for the third global dialogue and the investment focused event using the observer registration form for NGOs, which will be sent to the CFPs. Kindly note that **two representatives per constituency will be permitted to participate as observers in-person in the global dialogue and investment focused event**. CFPs are requested to nominate one participant from a developed country and one participant from a developing country from their constituency for in-person participation. CFPs are also invited to nominate up to two representatives to participate virtually in the global dialogue and the investment-focused event via the active virtual participation modality - one participant from developed countries and one participant from developing countries. Upon receiving the completed registration forms, CFPs should confirm the nominations and email the forms to [cool@unfccc.int](mailto:cool@unfccc.int). no later than **Friday, 15 May 2023**. For those who are not nominated and are interested in following the global dialogue and investment-focused event, it will also be broadcast live.
