## **NOTIFICATION**

Invitation to the fourth global dialogue and the fourth investment-focused event under the Sharm el-Sheikh mitigation ambition and implementation work programme

### 4 – 5 October 2024

On behalf of the co-chairs of the Sharm el-Sheikh mitigation ambition and implementation work programme, Amr Osama Abdel-Aziz and Lola Vallejo, I am pleased to invite constituencies of admitted non-governmental organizations (NGOs), to participate in the fourth global dialogue and the fourth investment-focused event under the work programme.

The fourth global dialogue and investment-focused event is being organized pursuant to decision 4/CMA.4, by which the CMA decided that at least two global dialogues shall be held each year as part of the work programme and requested the secretariat to organize those dialogues under the guidance of the cochairs of the work programme and will take place on 4 - 5 October 2024 in Sharm el-Sheikh, Egypt in a hybrid format.

Pursuant to the same decision, the co-chairs of the work programme have selected the topics "Cities: buildings and urban systems" to be discussed at each dialogue in 2024. The focus area of the fourth global dialogue will be urban systems. Following is an indicative list of subtopics for discussion:

- a) Spatial planning and low-carbon infrastructure
- b) Electrification and switching to net-zero emission resources
- c) Enhance carbon storage through green and blue infrastructure

**Distribution**: Focal points of constituencies of non-governmental organizations admitted as observers by the Conference of the Parties.

## Nomination and registration details

Given space limitations, participation of admitted NGOs will be limited to representatives nominated by NGO constituency focal points (CFPs). Nominated representatives must register for the fourth global dialogue and investment-focused event using the observer registration form for NGOs, which will be sent to the CFPs. Kindly note that **two representatives per constituency will be permitted to participate as observers in-person in the global dialogue and investment focused event**. CFPs are requested to nominate one participant from a developed country and one participant from a developing country from their constituency for in-person participation. CFPs are also invited to nominate up to two representatives to participate virtually in the global dialogue and the investment-focused event via the active virtual participation modality - one participant from developed countries and one participant from developing countries. Upon receiving the completed registration forms, CFPs should confirm the nominations and email the forms to cool@unfccc.int no later than Friday, 20 September 2024. The link to join will be shared by the secretariat upon the confirmation of nominations in due course. For those who are not nominated and are interested in following the global dialogue and investment-focused event, it will also be broadcast live.
