Report on the 10th meeting of the Katowice Committee of Experts on the Impacts of the Implementation of Response Measures

I. Opening of the meeting

- 1. The secretariat opened the 10^{th} meeting of the KCI (KCI 10) on Thursday 30 May 2024 at 9.30 a.m. Central European Summer Time and asserted that the quorum requirement had been met.
- 2. The table below reflects the attendance of KCI members at KCI 10. Observers who participated in the meeting are listed in annex I.

II. Organizational matters

A. Election of the Co-Chairs for 2024–2025

3. The KCI agreed to defer the election of its Co-Chairs to its 11th meeting (KCI 11) and appointed Angelina Tutuah Mensah and Moustapha Kamal Gueye to co-chair KCI 10 and any intersessional work prior to KCI 11.

B. Adoption of the agenda

4. The KCI adopted the agenda for its 10th meeting ¹ with an agreement to add engagement with Standing Committee on Finance (SCF) focal points to the KCI under agenda item 11, other matters.

C. Organization of work

5. The Co-Chairs presented, and the KCI took note of, the proposed work schedule for the meeting.²

D. Membership matters

6. The secretariat presented, and the KCI took note of, information on the membership status ³ and nominations for KCI membership from Eastern European States, Western European and other States, and Intergovernmental organizations.

III. Updates on relevant meetings, events and initiatives

A. Outcome of the United Nations Climate Change Conference in the United Arab Emirates and KCI activities

7. The secretariat presented, and the KCI took note of, information on this matter. The KCI emphasized the need to boost its outreach activities to increase awareness and uptake of its work by Parties and stakeholders.

B. Outlook for 2024

8. The secretariat presented, and the KCI took note of, information on this matter.

IV. Strategy session on implementing the workplan of the forum and its Katowice Committee on Impacts for 2020–2025 and monitoring the progress of implementation

A. Monitoring system to track the progress of implementation of mandates for the KCI

- 9. The secretariat presented a monitoring system to track the progress of implementation of mandates for the KCI, and KCI provided comments to further improve it including inclusion of timeline, deadlines and to include, among others, existing workplan activities, events, meetings, in order to make it comprehensive.
- 10. The KCI further agreed to use the revised tracking table starting from KCI 11 and to further improve it as needed.

B. Response to relevant mandates and invitations from the United Nations Climate Change Conference in the United Arab Emirates

11. The secretariat presented the relevant mandates and invitations from the United Nations Climate Change Conference in the United Arab Emirates and how the KCI can

respond to these mandates and invitations, and the KCI agreed on approaches to respond to these mandates.

12. The KCI requested the secretariat to inform the KCI of any invitations for submissions from the Conference of the Parties (COP), the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP) and the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA), the Subsidiary Body for Scientific and Technological Advice and/or the Subsidiary Body for Implementation, well in advance, in order for the KCI to respond, as appropriate, in a timely manner.

C. Strategy for implementing the activities from the outcome of the midterm review of the workplan of the forum and its KCI for 2020–2025

- 13. The Co-Chairs presented a draft strategy for implementing activities from the outcome of the midterm review of the workplan of the forum on the impact of the implementation of response measures and its KCI for 2020–2025.⁴
- 14. The KCI set out strategies to implement activities (b) and (e) of annex II of decisions 13/CP.28, 4/CP.18 and 19/CMA.5 (see annex II).

V. Implementation of the workplan of the Katowice Committee on Impacts for 2020–2025

- A. Enhance the capacity and understanding of Parties, through collaboration and input from stakeholders, on the assessment and analysis of the impacts of the implementation of response measures to facilitate the undertaking of economic diversification and transformation and just transition (activity 4)
 - 15. A member of the working group presented the revised draft framework for a technical paper for this activity.⁵
 - 16. The KCI considered the draft framework and provided comments and guidance for improving it (see annex III). The KCI agreed to finalise the draft framework for the technical paper electronically after KCI 10 meeting and proceed with the development of the modules, each led by a working group in collaboration with other organisations, where possible.
- B. Promote the availability and use of guidelines and policy frameworks to assist Parties in promoting just transition of the workforce and the creation of decent work and quality jobs within and across sectors, including training, retooling, retraining and reskilling systems and stakeholder engagement strategies (activity 6)
 - 17. A member of the working group presented the draft compilation and synthesis on guidelines and frameworks on just transition of the workforce and the creation of decent work and quality jobs.⁶
 - 18. The KCI took note of the draft compilation and synthesis, and provided comments and guidance for improving it (see annex IV). The KCI requested the working group to revise the draft compilation and synthesis taking into account the comments and guidance provided by the KCI and input from the exchange and sharing of experience and best practices⁷ to be held under the forum at SB 60. The KCI agreed to finalize the draft compilation and synthesis electronically after KCI 10.

- 19. The KCI agreed to discuss, at KCI 11, possible recommendations to the forum to be included in the 2024 KCI annual report as possible recommendations for actions by the COP, the CMP and the CMA.
- C. Facilitate the development and exchange of regional, country- and/or sector-specific case studies and approaches on (1) economic diversification and transformation and just transition of the workforce and creation of decent work and quality jobs, and (2) assessment and analysis of the impacts of the implementation of response measures with a view to understanding the positive and negative impacts (activity 7)
 - 20. The KCI agreed to defer the consideration of this agenda item to its next meeting.

D. Share experience and best practices in reporting and informing on efforts to assess and analyse the impacts of the implementation of response measures (activity 10)

- 21. A member of the working group presented an update on the implementation of this activity, including the input received in response to the call for input⁸ launched by the KCI for this activity.
- 22. The KCI agreed on the elements that will be covered when it will organize an exchange and sharing of experience and best practices pertaining to this activity at KCI 11.
- 23. The KCI also agreed to invite some organizations that responded to the call for input and Consultative Group of Experts (CGE) to share experience.

VI. Rules of procedure of the Katowice Committee on Impacts

24. The secretariat presented the draft updated rules of procedure of the KCI. The KCI considered the draft and agreed to further consider it at KCI 11.

VII. Implementation of mandates arising from decisions 20/CP.27, 7/CMP.17 and 23/CMA.4

- 25. The secretariat presented a concept note on capacity-building programme to assist Parties in undertaking an assessment of the impacts of the implementation of response measures¹⁰ and provided comments and guidance for improving it.
- 26. The KCI requested the secretariat to include a gap analysis in the revised concept note, and agreed to consider it at KCI 11.
- 27. The KCI further agreed to invite representatives of other constituted bodies including CGE, and practitioners or organizations to share experience in capacity-building activities at KCI 11.

VIII. Communication and outreach strategy

28. The secretariat presented, and the KCI took note of, the key performance indicators for monitoring communication and outreach efforts of the KCI.

- 29. Further, the KCI provided further guidance on elements that can guide the communication and outreach activities, including: rebranding of the KCI, accessibility and user-friendliness of the website, the use of social media, how to engage with stakeholders through global dialogue, regional events and relevant UN meetings, and establishing a group of friends of the KCI as an informal platform.
- 30. The KCI agreed to establish a working group on communication and outreach and to provide an update at KCI 11.

IX. Mainstreaming gender considerations

- 31. The gender focal points of the KCI reported on progress in mainstreaming gender considerations in the work of the KCI, which included taking into account gender aspects in the ongoing work of the KCI on draft papers, ensuring gender balance of speakers at KCI side events and of appointed experts, and establishing the informal network of experts on gender for response measures.¹¹
- 32. The KCI took note of the information provided.

X. Dates and venues of the next meeting

33. The secretariat shared the status of preparation for KCI 11. The KCI members made observations on the timing of KCI 11 taking into consideration other important events in the international calendar.

XI. Other matters

A. Enhance the work of the Katowice Committee on Impacts

34. The Co-Chairs presented a background note on enhancing the work of the KCI, ¹² and the KCI agreed that the elements in the background note, along with views exchanged on this matter, will guide the work of KCI and communication and engagement activities.

B. Engagement with Standing Committee on Finance focal points to the Katowice Committee on Impacts

- 35. The KCI welcomed Mohammad Ayoub and Kevin Adams, the SCF focal points to the KCI, to the KCI 10.
- 36. The KCI appreciated the initiative and exchange of information and looks forward to further collaborating with SCF.

XII. Closure of the meeting

37. The Co-Chairs closed the meeting on Friday 31 May 2024 at 9 p.m. Central European Summer Time. The Co-Chairs thanked the KCI members and observers for their active participation.

Annex III

Enhance the capacity and understanding of Parties, through collaboration and input from stakeholders, on the assessment and analysis of the impacts of the implementation of response measures to facilitate the undertaking of economic diversification and transformation and just transition (activity 4)

I. Comments and guidance for revising and finalizing the draft framework for a technical paper

- 1. Members and observers made suggestions in relation to elements to be covered by the framework:
- (a) Clear reference to the concept note on capacity-building programme to assist Parties in undertaking an assessment of the impacts of the implementation of response measures:
- (b) Inclusion of other regional expert organizations in just transition and economic diversification, including the other regional commissions of the United Nations;
- (c) Inclusion of academic institutions, universities and research centres in the respective regions;
- (d) Taking all KCI knowledge products, such as the technical paper for activity 9, into account when developing the modules;
- (e) Broadening the coverage of stakeholders beyond private sector, for example to also consider civil society, in modules that involve gathering information from stakeholders;
 - (f) Inclusion of new a module on emerging economic models.

Annex IV

Promote the availability and use of guidelines and policy frameworks to assist Parties in promoting just transition of the workforce and the creation of decent work and quality jobs within and across sectors, including training, retooling, retraining and reskilling systems and stakeholder engagement strategies (activity 6)
