MESSAGE TO ADMITTED NON-GOVERNMENTAL ORGANIZATIONS

First dialogue under the United Arab Emirates work programme on just transition pathways

2 - 3 June 2024

I refer to the <u>Message to Parties and observers dated 27 March 2024</u> regarding discussion topic for the First dialogue under the United Arab Emirates Just Transition Work Programme in 2024 (JTWP) and am pleased to invite admitted non-governmental organizations (NGO) to the first dialogue under the JTWP.

Under the guidance of the Chair of the Subsidiary Body for Scientific and Technological Advice (SBSTA), Harry Vreuls, and Chair of the Subsidiary Body for Implementation (SBI), Nabeel Munir, the first dialogue will take place in Bonn, Germany from 2 - 3 June 2024 in a hybrid format. Two half-day sessions are planned on 2 June 2024 from 13:00 to 17:00 Central European Summer Time (CEST) and 3 June 08:00 to 12:00 CEST. The first dialogue is being organized pursuant to decision 3/CMA.5, by which the CMA decided that at least two dialogues shall be held each year as part of the work programme and requested the secretariat to organize those dialogues under the guidance of the Chair of SBSTA and Chair of SBI.

Pursuant to the same decision, the Chair of SBSTA and Chair of SBI have selected the topic: "Just Transition pathways to achieving the goals of the Paris Agreement through NDCs, NAPs and LT-LEDs" to be discussed at the first dialogue.

Nomination and registration details

Constituency Focal Points (CFP) of admitted NGOs are invited to nominate up to two persons for either in person or virtual participation per constituency to participate as observers in the dialogue. Representatives of admitted NGOs nominated by constituency focal points must register using the online registration form, which will be communicated to the nominated participants. CFPs are requested to submit their nomination list no later than **17 May 2024** 23:59 CEST via <u>cool@unfccc.int</u>. In view of the need to confirm the arrangements for the dialogue as early as possible, nominations received after the deadline may not be processed.

Distribution: To constituency focal points of non-governmental organizations admitted as observers by the Conference of the Parties.

Time permitting, virtual participants may have an opportunity to participate in the discussions. CFPs are encouraged to ensure balanced participation of developed and developing country representation, and to take gender considerations into account.
