# **Annex**

Dear colleagues,

The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement at its third session established the ad hoc work programme on the new collective quantified goal on climate finance for 2022–2024 and requested the co-chairs of the ad hoc work programme to conduct four technical expert dialogues (TEDs) per year thereunder.<sup>1</sup>

The fifth TED was held at the Vienna International Centre in Vienna from 8 to 10 March 2023 under the themes of temporal scope and structure of the goal.<sup>2</sup> The sixth TED was convened in conjunction with the fifty-eighth sessions of the subsidiary bodies, at the Ameron Bonn Hotel Königshof in Bonn from 12 to 13 June 2023 on the themes of quantity, mobilization and provision of financial sources.<sup>3</sup> The seventh TED was held on 30 September to 2 October 2023 in Geneva focusing on the themes quality and transparency arrangements.<sup>4</sup>

Further to the notification issued on 19 October 2023,<sup>5</sup> we would like to inform constituencies of admitted NGOs regarding the **new schedule of the eighth TED**. Please be informed that it will be held on **Tuesday**, **28 November from 2:00 p.m. to 8:00 p.m (GMT+4)**. in conjunction with **COP 28, CMP 18, and CMA 5** in Dubai, United Arab Emirates. As indicated in the notification issued, we intend to focus the eighth TED on the theme of **stocktake and outlook to 2024**.
