## **MESSAGE TO PARTIES AND OBSERVER STATES**

### **United Nations Climate Change Conference, COP 29**

#### **Confirmation of the Heads of State and Government World Leaders Climate Action Summit**

**and**

#### **Alphabetical List of Speakers - COP29 High-Level Segment**

The secretariat refers to the high-level segment of the United Nations Climate Change Conference 2024 (COP29/CMP19/CMA 6), scheduled to take place from 11 to 22 November 2024 in Baku, Azerbaijan, and to the World Leaders Climate Action Summit (WLCAS), which is set to be held from 12 to 13 November 2024 as part of COP 29.

Kindly refer to the annex for the list of Parties, arranged **in alphabetical order**, that registered by the deadline of Friday, 27 September, and have nominated their Head of State or Government (HOS/G) to deliver a national statement during the first part of the high-level segment of COP29, scheduled for 12 and 13 November 2024.

Also included is the list of Parties, arranged in alphabetical order, that registered by the deadline of Friday, 27 September, and have nominated representatives to deliver national statements and statements on behalf of groups during the resumed high-level segment on 19 and 20 November. National statements during the resumed high-level segment of COP29 will be delivered by those Parties whose Head of State or Government did not deliver a national statement during the first part of the high-level segment, held on 12 and 13 November.

**Distribution:** To Parties and observer States to the United Nations Framework Convention on Climate Change through their national focal points and diplomatic missions accredited to the Federal Republic of Germany and the Republic of Azerbaijan.



As noted, the list is arranged in alphabetical order and does not reflect the order of speakers. The preliminary list of speakers for the first part of the high-level segment for Heads of State or Government (HOS/G), indicating the order of delivery for national statements, will be published no later than **Monday, 4 November 2024**.

The list of speakers for the resumed high-level segment, indicating the order of delivery for national and group statements, will be published no later than **Thursday, 14 November 2024**.

**Confirmation of Attendance of the Heads of State and Government to the Government of the Republic of Azerbaijan**

Parties are reminded that the registration to deliver a national statement does not constitute confirmation of the participation of their Head of State or Government (HOS/G) at the World Leaders Climate Action Summit (WLCAS) to the Government of the Republic of Azerbaijan.

For those Parties that have not yet done so, kindly confirm the attendance of your Head of State or Government (HOS/G) at the World Leaders Climate Action Summit (WLCAS) to the Government of the Republic of Azerbaijan as soon as possible. **This confirmation is essential to ensure that all arrangements, including accommodations, are in place for the Heads of State or Government during their stay in Baku, Azerbaijan.**

Confirmation of attendance of the Heads of State or Government should be submitted by Verbal Note to the Government of the Republic of Azerbaijan through the diplomatic missions, as well as via the email address [secretariat.wls@cop29.az](mailto:secretariat.wls@cop29.az) (COP29 Leaders' Summit Protocol Headquarter).
