## Method for selecting priorities

- 1. Identify priorities that have already been identified (e.g. NAPA, INC, NDC)
- Extrapolate priorities from sectoral plans and other sources
- 3. Compile adaptation actions into priority programs
- 4. Identify components for each action

Additional priorities can be added, and existing priorities will be further developed during the full NAP stage.

# Priority Sectors for the NAP

The First NAP addresses 9 priority sectors:

- Agriculture, Livestock and Fisheries
- Disaster risk reduction
- Environment, Ecosystems, and Biodiversity conservation
- Energy
- Health
- Tourism and Recreation
- Human Settlement
- Industry, Infrastructure, and Transportation
- Water Resources

Each sector includes baseline information, basic vulnerabilities, sectoral linkages, and suggested adaptation priorities

## SHORT-TERM ADAPTATION PROGRAMS (Implementation strategy over next 3 years)

- Identified needs have been consolidated into three interlinked short-term programs comprising 57 actions. The implementation programmes address three interrelated supporting systems for the NAP process:
  - ❖ Programme 1: Improved coordination to support climate change adaptation and planning: This programme addresses vertical and horizontal coordination and includes activities to formally establish the institutional arrangements for adaptation planning at all levels

## Implementation strategy over next 3 years

 Programme 2: Improving human and institutional capacities to support NAP process: This programme sets up comprehensive capacity building measures for government staff and nongovernment stakeholders so that they can fulfil the responsibilities.

## Implementation strategy over next 3 years

 Programme 3: Data, information and knowledge management systems enhanced to support climate change adaptation planning processes: This programme includes actions to establish the data and information infrastructure and associated protocols and support services that are needed to support evidence-based planning and decisionmaking

## Immediate next steps in further implementation of the NAP

- The NAP takes a first step towards establishing a coherent and effective National Adaptation Plan process for South Sudan. The Department of Climate Change will take the lead in completing the following steps to enhance the NAP
- 1. Formalizing institutional arrangements, establishing a formal legal mandate and ensuring buy in and ownership of line agency stakeholders
  - This can be achieved largely through the support of GCF readiness resources

## 2. Stocktaking of progress and updating prioritized adaptation actions

 Department of Climate Change should first coordinate a stocktaking exercise to gauge progress on the priorities and programmes that have been compiled in Chapter 6, with a particular focus on progress made with respect to implementing South Sudan's NAPA

#### 3. Formulating NAP communication and outreach strategy

#### 4. Costing and financing plan

 South Sudan does not have many sources of climate finance from international public and private sources, or domestic public and private sources because public policy frameworks to facilitate this funding are not well developed

## 5. Monitoring, evaluation, and learning framework

 The monitoring and evaluation framework will include SMART indicators for determining progress during the first NAP process. This section will also describe mechanisms for capturing lessons learned to be incorporated into the enhanced NAP, to be completed by 2022
