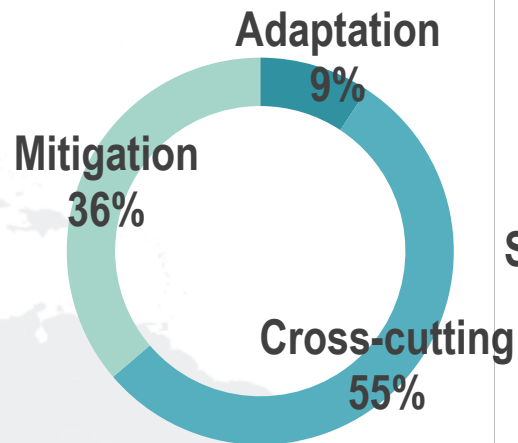

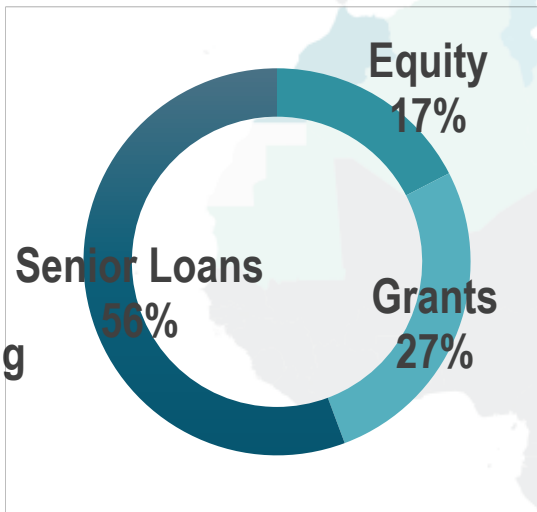
PORTFOLIO IN THE ARAG REGION



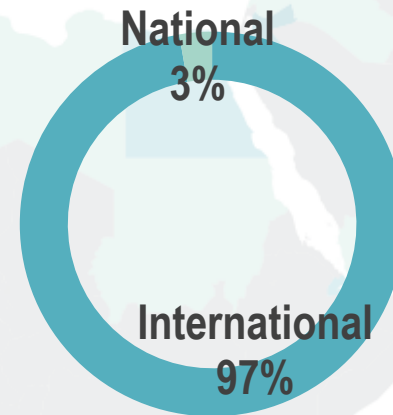
