Option 1 {CMA 7 (2025) and SBSTA 64 (June 2026) for concluding consideration at CMA8 (2026)}

- 2. Decides to continue consideration of this matter at its seventh session (November 2025) with a view to concluding the consideration at its eighth session (November 2026), taking into account the compilation of in-session submissions referred to in paragraph 1 above [and findings in the annual updates to the synthesis report on nationally determined contributions under the Paris Agreement²].
- 3. *Requests* the secretariat to organize an in-session workshop, with the participation of Parties and observers, on this matter to be held in conjunction with the sixty-fourth session (June 2026) of the SBSTA with a view to facilitating an exchange of views thereon.

Option 2 {CMA 8 (2026) and SBSTA 66 (June 2027) for concluding consideration at CMA9 (2027)}

- 4. *Decides* to continue consideration of this matter at its eighth session (November 2026) with a view to concluding the consideration at its ninth session (November 2027), taking into account the compilation of in-session submissions referred to in paragraph 1 above [and findings in the annual updates to the synthesis report on nationally determined contributions under the Paris Agreement³].
- 5. Requests the secretariat to organize an in-session workshop, with the participation of Parties and observers, on this matter to be held in conjunction with the sixty-sixth session (June 2027) of the SBSTA with a view to facilitating an exchange of views thereon.

Option 3 {CMA 9 (2027) and SBSTA 68 (June 2028) for concluding consideration at CMA 10 (2028)}

- 6. Decides to continue consideration of this matter at its ninth session (November 2027) with a view to concluding the consideration at its tenth session (2028), taking into account the compilation of in-session submissions referred to in paragraph 1 above [and findings in the annual updates to the synthesis report on nationally determined contributions under the Paris Agreement⁴].
- 7. Requests the secretariat to organize an in-session workshop, with the participation of Parties and observers, on this matter to be held in conjunction with the sixty-eighth session (2028) of the SBSTA with a view to facilitating an exchange of views thereon.
