b/ UNESCO has four associate members: Aruba, British Virgin Islands, the Cook Islands, which is a self-governing territory in free association with New Zealand, and Netherlands Antilles.

c/ In ICAO, USSR membership covers the Byelorussian Soviet Socialist Republic and the Ukrainian Soviet Socialist Republic. In addition to the members listed in the table, the Cook Islands, which is a self-governing territory in free association with New Zealand, the Federated States of Micronesia and the Marshall Islands have adhered to the Convention on Civil Aviation and consequently are listed by ICAO as members.

d/ In addition to the members listed in the table, the Cook Islands, which is a self-governing territory in free association with New Zealand, is a full member of WHO.

e/ In addition, Bulgaria, Czechoslovakia, Namibia and Switzerland have not yet finalized membership procedures with the IMF.

f/ The 168 members of UPU include the following members not listed in the table: Netherlands Antilles and Aruba and the Overseas Territories for the international relations of which the Government of the United Kingdom of Great Britain and Northern Ireland is responsible.

g/ The 160 members of WMO include the following five members not listed in the table which maintain their own meteorological service: British Caribbean Territories, French Polynesia, Hong Kong, Netherlands Antilles and New Caledonia.

i/ In addition, there is one country (Saint Vincent and the Grenadines) which has not yet finalized membership procedures.

j/ The 97 members of GATT include Hong Kong (not listed in the table). In addition, there are 28 countries (Algeria, Angola, Bahamas, Bahrain, Brunei Darussalam, Cambodia, Cape Verde, Dominica, Equatorial Guinea, Fiji, Grenada, Guinea-Bissau, Kiribati, Mali, Mozambique, Papua New Guinea, Qatar, Saint Christopher and Nevis, Saint Lucia, Saint Vincent and the Grenadines, Sao Tomé and Príncipe, Seychelles, Solomon Islands, Swaziland, Tonga, Tuvalu, the United Arab Emirates and Yemen) where GATT had been applied before independence and which now, as independent States, maintain a de facto application of GATT pending final decisions as to their future commercial policy.

AAA. REGARDING YOUR CABLE TO ME OF 28 FEBRUARY 1991, WE ARE NOT AWARE OF ANY STEPS BEING TAKEN AT PRESENT BY EITHER THE MARSHALL ISLANDS OR THE FEDERATED STATES OF MICRONESIA (FSM) FOR ADMISSION TO MEMBERSHIP IN THE UN.

BBB. AS TO THE APPLICABILITY OF PARA. 1 OF GA RESOLUTION 1995(XIX), HOWEVER, IT WOULD SEEM BOTH THE MARSHALLS AND FSM ARE COVERED. THE MARSHALLS AND FSM ARE BOTH ALREADY FULL MEMBERS OF ACO. (SEE <sup>ATTACHED</sup> FOOTNOTE (C) ON PAGE 10 OF THE ACC PUBLICATION ENTITLED "UNITED NATIONS SYSTEM OF ORGANIZATIONS AND DIRECTORY OF SENIOR OFFICIALS 1990/1991").

PLEASE NOTE IN THAT CONNECTION THAT ALTHOUGH THE COOK ISLANDS ARE FULL MEMBERS OF SOME AGENCIES, IN OUR VIEW THEY STILL DO NOT CONSTITUTE AN INDEPENDENT SOVEREIGN STATE FULLY RESPONSIBLE FOR THE CONDUCT OF ITS OWN INTERNATIONAL RELATIONS. HENCE, THE COOK ISLANDS SHOULD NOT BE CONSIDERED A "STATE" UNDER PARA.1 OF RESOLUTION 1995(XIX). BEST REGARDS. JOHNSON.

WITH REFERENCE TO A MEMORANDUM DATED 29 JANUARY 1991 BY WHICH THE LEGAL COUNSEL INFORMS THE DIRECTOR-GENERAL FOR DISC THAT THE FEDERATED STATES OF MICRONESIA AND THE MARSHALL ISLANDS SHOULD NOW BE CONSIDERED "NON-MEMBER STATES" I WOULD BE INTERESTED TO RECEIVE ANY INFORMATION WHICH OLA MAY HAVE ON STEPS UNDER WAY, IF ANY, BY THE FEDERATED STATES TO APPLY FOR MEMBERSHIP IN THE UNITED NATIONS, WHEN AS SUCH A DEVELOPMENT MAY WOULD FACILITATE THE APPLICATION OF PARAGRAPH ONE OF GA RESOLUTION 1995(KIX) ON THE ESTABLISHMENT OF UNCTAD.
