Pursuant to the rules of procedure of the Technology Executive Committee, contained in annex II to decision 4/CP.17, I am pleased to notify Parties and observer States to the United Nations Framework Convention on Climate Change, the Kyoto Protocol, and the Paris Agreement of the following meetings:

- The **31**<sup>st</sup> meeting of the Technology Executive Committee, to be held in Bonn, from 9 to 11 September 2025, from 9 a.m. to 5 p.m., Central European Summer Time (CEST);
- The joint session of the Technology Executive Committee and the Advisory Board of the Climate Technology Centre and Network, to be held in Bonn, on 12 April 2025, from 9 a.m. to 5 p.m., CEST.

The meetings will be open to observers in accordance with the above-mentioned decision. In accordance with decision 23/CP.18 and with a view to informing more effective climate change policy that addresses the needs of women and men equally, the UNFCCC secretariat encourages the nomination of women participants. Owing to space limitations, access may be limited for in-person participation. However, the meetings will be webcast through the UNFCCC website. Interested representatives of Parties and observer States should register for the meetings <u>here</u>.

The deadline for registering as an observer for the meetings is by 6 p.m. on **Friday**, **1 August 2025**, CEST. In view of the need to confirm the arrangements for the meetings as early as possible, observer registrations received after this deadline may not be processed.
