### **Ninth meeting of the Executive Committee of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts**

**Bonn, Germany**  
**9–11 April 2019**

I am pleased to notify constituencies of admitted non-governmental organizations (NGOs) that the ninth meeting of the Executive Committee of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts will take place in Bonn, Germany, from 9 to 11 April 2019.

The Constituency Focal Point must nominate representatives to attend. Once nominated by the Constituency Focal Point, representatives must register for the meeting using the Observer Registration Form for NGOs, which can be obtained from the Constituency Focal Points. The form should be completed and returned to the focal point. The deadline for registration as an observer is **Friday, 8 March 2019**.

The meeting of the Executive Committee will be open to admitted observer organizations in accordance with the modalities and procedures adopted by decision 2/CP.20. The Executive Committee strives for inclusiveness in its work, yet space and budget limitations may constrain participation.

Upon receiving the registration form, the Constituency Focal Points should confirm the nomination(s) and forward the registration form to the secretariat at [cool@unfccc.int](mailto:cool@unfccc.int). In view of the need to confirm the arrangements for the meeting as early as possible, observer registrations for NGOs received after this deadline may not be processed.

**IMPORTANT INFORMATION FOR NGOs OBSERVERS**

- This registration is **only valid** for the ninth meeting of the Executive Committee.
- Please be advised that the **nominee is responsible** for making his/her own travel, visa and accommodation arrangements.
- All foreign delegates entering the Federal Republic of Germany must have a valid passport. Participants requiring a visa are strongly encouraged to contact the appropriate consular authorities as soon as this notification is received. The issuance of a visa for Schengen States may take up to two weeks from the date of submission of the visa application. To facilitate the issuance of a visa, this notification should be attached to the visa application.
- **Participants are advised that obtaining a Schengen visa is contingent on the participant securing comprehensive insurance that covers the entire stay. If you are travelling more than once, it is recommended to directly get insurance that covers the time period of all intended stays.**
- Consequently, participants are therefore **strongly advised** to obtain international travel and medical insurance to cover themselves from the time they depart for the meeting until the time they return.
