### **The first meeting of the Local Communities and Indigenous Peoples Platform Facilitative Working Group**

**Bonn, Germany**  
**14–16 June 2019**

I am pleased to notify constituencies of admitted non-governmental organizations (NGOs) that the **first meeting of the Local Communities and Indigenous Peoples Platform Facilitative Working Group** (hereinafter referred to as the LCIPP Facilitative Working Group) will take place in Bonn, Germany, from 14 to 16 June 2019.

The meeting will be open to observers in accordance with the modalities and procedures adopted by decision 2/CP.24. The LCIPP Facilitative Working Group strives for inclusiveness in its work, subject to budget and venue capacity.

The Constituency Focal Point must nominate representatives to attend. The deadline for the Constituency Focal Points to submit registration is **Friday, 24 May 2019**. In view of the need to confirm the arrangements for the meeting as early as possible and acknowledging that space and budget limitations may constrain participation, observer registrations received after this deadline may not be processed.

Once nominated by the Constituency Focal Point, representatives must register for the meeting using the Observer Registration Form for NGOs, which can be obtained from the Constituency Focal Points. The form should be completed and returned to the focal point.

Upon receiving the registration form, the Constituency Focal Points should confirm the nomination(s) and forward the registration form to the secretariat at [cool@unfccc.int](mailto:cool@unfccc.int).

### IMPORTANT INFORMATION FOR NGOs OBSERVERS

- This registration is **only valid** for the first meeting of the LCIPP Facilitative Working Group.
- Please be advised that the **nominee is responsible** for making his/her own travel, visa and accommodation arrangements.
- All foreign delegates entering the Federal Republic of Germany must have a valid passport. Participants requiring a visa are strongly encouraged to contact the appropriate consular authorities as soon as this notification is received. The issuance of a visa for Schengen States may take up to two weeks from the date of submission of the visa application. To facilitate the issuance of a visa, this notification should be attached to the visa application.
- **Participants are advised that obtaining a Schengen visa is contingent on the participant securing comprehensive insurance that covers the entire stay. If you are travelling more than once, it is recommended to directly get insurance that covers the time period of all intended stays.**
- Consequently, participants are therefore **strongly advised** to obtain international travel and medical insurance to cover themselves from the time they depart for the meeting until the time they return.
