#### **Climate Week 2 - Addis Ababa, Ethiopia 1 - 6 September 2025**

The secretariat refers to the [Message to Parties](#) and observers dated 2 July 2025 regarding the second Climate Week 2025 which will be held from 1 to 6 September 2025 in Addis Ababa, Ethiopia.

In an effort to streamline the nomination process for the mandated events taking place during the Climate Week and to avoid multiple communications, the secretariat is issuing a single consolidated message to constituencies of admitted non-governmental organizations (NGOs) for all mandated events taking place at the Climate Week. All mandated events will be organized in accordance with their respective mandates under the Conference of Parties serving as the meeting of Parties to the Paris Agreement and of the Subsidiary Bodies.

Participation of admitted NGOs in mandated events (Section I) is facilitated through the [NGO constituencies](#), so as to aim for a balanced representation of the admitted non-governmental organizations. Please note that nomination of representatives will be at the discretion of the respective NGO constituencies. In this context, Constituency Focal Points (CFP) are invited to nominate their representatives for the mandated events in Section I.

## **I. Nomination and registration for mandated events inviting nominations from CFPs and information on other events**

CFPs are invited to nominate participants for in-person attendance and virtual participation, where applicable, for the mandated events listed below.

Nomination lists of representatives to mandated events should be communicated to the secretariat by the CFPs via [cool@unfccc.int](mailto:cool@unfccc.int) by **1 August 2025, CEST 23:59** at the latest. CFPs are further encouraged to nominate individuals with expertise and experience relevant to the event for which they are nominated.

Admitted NGOs are advised that nomination through the CFPs is the only official channel for nominating participants for the events during the Climate Week. The secretariat is not in a position to process nominations submitted by any other method. Please note that it is imperative that a correct and unique email address be provided for each nominated participant for swift processing of nominations and initiating registration. Once a participant has been nominated for an event, they will receive an email with registration details via Indico UN. Logistical details related to travel and participation will be shared directly with registered participants.

In view of the need to confirm the arrangements for the Climate Week events as early as possible, the secretariat will not be in a position to process late nominations.

3. **Unlocking Article 6 for climate finance and raising ambition<sup>3</sup>**, 5 and 6 September

- Nominate **one in-person participant** per Constituency.
- Nominate up to **one virtual participant** per Constituency to participate actively in discussions, time-permitting.
- Additional details: This two-day workshop as part of the Climate Week, will explore the catalytic role of carbon markets—especially under Article 6.4 of the Paris Agreement—in unlocking climate finance and accelerating Nationally Determined Contribution (NDC) implementation across Africa.  
Bringing together governments, private sector, regional and multilateral organizations, and technical experts, the event will blend information sessions, interactive discussions, and peer learning. The workshop will be designed to build foundational knowledge, share regional experiences, and chart practical pathways for scaling up investment and participation in high-integrity carbon markets.

## **II. Implementation Forum**

The **Implementation Forum** will take place on 3 and 4 September and will feature a series of events. Over the course of the two days, the Forum will include, among others, the Climate Week Opening Ceremony; a number of events hosted by the COP 30 Presidency, including events on “Mutirão”, climate action agenda and a mandated dialogue on advancing the role of local communities in the UNFCCC Process. Other sessions during the Implementation Forum will focus on climate finance and adaptation, for example the Adaptation Finance event and Public-Private dialogue on Finance. As in [Climate Week 1 2025](#), a dedicated space will be created for the Implementation Labs, which will focus on thematic issues, such as forests, agriculture, sustainable cities, energy transition and access, and carbon markets.
