Message from the co-chairs of the ad hoc work programme on the new collective quantified goal on climate finance

Dear colleagues,

Further to our communication of <u>12 April 2023</u> regarding the sixth technical expert dialogue under the ad hoc work programme on the new collective quantified goal on climate finance, we are pleased to provide further information thereon.

The dialogue will take place in Bonn on **12 June 2023 from 9 a.m. to 6 p.m. and on 13 June 2023 from 2 to 6 p.m. Central European Summer Time** in conjunction with the fifty-eighth sessions of the subsidiary bodies under the theme of "**Quantity, mobilization and provision of financial sources**". Further details, including provisional programme and logistical information, will be made available in due course at <u>https://unfccc.int/NCQG</u>.

Representatives of admitted NGOs nominated by constituency focal points must register for the dialogue using the observer registration form for NGOs, which has been sent to constituency focal points. Kindly note that, owing to the limited capacity of the venue, only **two representatives per constituency** will be permitted to participate in person. The deadline for registration through the constituency focal points is **Friday**, **26 May 2023**.

All other interested observers may participate virtually. The deadline for registration for virtual participation through the constituency focal points is **Friday**, **2 June 2023**. In view of the need to confirm arrangements for the dialogue as early as possible, registrations received after the abovementioned deadlines may not be processed. Further details relevant to in-person and virtual participation in the dialogue will be communicated directly to the registered participants.

Once the constituency focal points have confirmed their nominations, the registration forms should be emailed to <u>cool@unfccc.int</u>.

In addition, to allow for inputs to be reflected in the organization of the sixth technical expert dialogue, we would like to remind Parties, constituted bodies under the Convention and the Paris Agreement, operating entities of the Financial Mechanism, climate finance institutions, observers and other stakeholders, particularly from the private sector, to submit views thereon on the basis of the guiding questions in the notification dated 12 April 2023 via the submission portal¹ by **Wednesday**, **10 May 2023**.
