Dear colleagues,

we are pleased to provide further information on the organization of the second workshop in 2024 under the Sharm el-Sheikh dialogue.

The second workshop in 2024 will take place in **Sharm el-Sheikh, Egypt, on Sunday, 6, and Monday, 7 October 2024, in a hybrid format**. The focus topics of the second workshop, as announced in the [message](#) dated 6 May 2024, will be on the role of the international financial system and of different actors within and outside the Paris Agreement, and on transparency and credibility with a focus on the avoidance of greenwashing and maladaptation. Further details, including the provisional programme and logistical information, will be made available in due course at <https://unfccc.int/sharm-el-sheikh-dialogue>.

The second workshop will take place in conjunction with a series of events that are held back to back in Sharm el-Sheikh, Egypt. All of the events will be organized in accordance with their respective mandates under the CMA and Subsidiary Bodies.

- Second Dialogue under the United Arab Emirates just transition work programme, **2-3 October**
- Fourth global dialogue and fourth Investment focused event under the Sharm el-Sheikh Mitigation Ambition and Implementation work programme, **4-5 October**
- Second workshop in 2024 under the Sharm el-Sheikh dialogue on the scope of Article 2, paragraph 1(c) and its complementarity with Article 9 of the Paris Agreement, **6-7 October**
- Workshop under the United Arab Emirates–Belém work programme on indicators, **8-9 October**

All of the four above mentioned events will follow separate registration processes according to their respective mandates.

### **Nomination and participation**

Given space limitations, participation of admitted NGOs will be limited to representatives nominated by NGO constituency focal points (CFPs). Nominated representatives must register for the dialogue using the online registration form, which will be communicated to the nominated participants. Kindly note that, owing to the limited capacity of the venue, only **two representatives per constituency** will be permitted to participate **in person**. Constituency focal points are requested to submit their nomination list, including email addresses, to [cool@unfccc.int](mailto:cool@unfccc.int) no later than **Friday, 30 August 2024**.

Other interested observers may actively participate virtually. The deadline for **registration for virtual participation** through the constituency focal points is **Friday, 20 September 2024**. Kindly note also that the workshop will be broadcasted live via webcast, and the link will be made available on the event webpage prior to the workshop.

In view of the need to confirm arrangements for the workshop as early as possible, registrations received after the above-mentioned deadlines may not be processed.
