## NOTIFICATION TO CONSTITUENCIES OF ADMITTED NON-GOVERNMENTAL ORGANIZATIONS

## High-level Ministerial Dialogue on the New Collective Quantified Goal on Climate Finance

## 9 October 2024 Baku, Azerbaijan

On behalf of the incoming COP 29, CMP 19 and CMA 6 Presidency, I am pleased to notify constituencies of admitted non-governmental organizations (NGOs) that the **2024 high-level ministerial dialogue on the new collective quantified goal on climate finance** will take place on **Wednesday**, **9 October 2024** at the Heydar Aliyev Center in Baku, Azerbaijan.

The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA), at its third session, decided to convene high-level ministerial dialogues on the new collective quantified goal on climate finance starting in 2022 and ending in 2024, ensuring effective political engagement and open, meaningful, and robust discussion. The 2024 high-level ministerial dialogue will be informed by the reports on the technical expert dialogues and meetings under the ad hoc work programme and submissions by Parties and non-Party stakeholders in the context of ad hoc work programme on the new collective quantified goal on climate finance.

This dialogue aims to provide guidance for the deliberations on setting the new collective quantified goal on climate finance at CMA 6. The incoming CMA 6 President will prepare a summary of the deliberations at the high-level ministerial dialogue, including recommendations, for consideration by CMA 6.

Regarding on-site participation, representatives of admitted NGOs nominated by constituency focal points must register for the dialogue using the online registration form, which will be communicated to the nominated participants. Kindly note that, owing to the limited capacity of the venue, **two representatives per constituency** at the head of organization level, will be permitted to participate **in person**. Constituency focal points are requested to submit their nomination list no later than **Monday**, **30 September 2024** via cool@unfccc.int.

Recognizing that not all interested observers may be able to attend the 2024 high-level ministerial dialogue on the new collective quantified goal on climate finance in person, arrangements are being made for the dialogue to have a webcast.
