

OECD submission to the Standing Committee on Finance

This submission is provided in response to the <u>call for evidence on "information and data for the preparation of the 2018 Biennial Assessment and overview of Climate Finance Flow"</u>. The OECD Secretariat welcomes the opportunity to provide input based on its methodological and statistical expertise in tracking financial flows. These have been detailed in previous submissions to the UNFCCC, as well as in selected publications. These are outlined below.
