Set ambitious national targets for Ocean renewable energy and deliver the mitigation that can achieve

Explore opportunities through the UNESCO IOC's Decade for Ocean Science

Regular Joint sessions between IPCC and IPBES is key - joint recommendations to ensure as we chart the way forward for climate we do not introduce perverse incentives

Submitting enhanced eonomy-wide NDCs ensures the need for holistic and cross-cutting action

Provide funding and methodologies to encourage action in local government. Activate the community to protect marine ecosystems. Increase difusion about the multilateral actions and their results.

It is important that efforts to address the ocean and climate change interface within the UNFCCC support the work carried out by other international bodies in performing their respective mandates, and not duplicate them.
