## Highlights of work undertaken in the first half of 2021:

- The JISC maintained its operations with the infrastructure and capacity to support JI operations, as needed, and by monitoring the intergovernmental negotiation process.
- The JISC, at its last meeting (JISC 43), elected Ms. Vanessa Leonardi as the Chair and Mr. Derrick Oderson as the Vice-Chair, respectively.
- The JISC at JISC 43 agreed to its annual report to the CMP for the period from 18 September 2019 to 16 October 2020, which was published on 3 November 2020. The next annual report will be considered at JISC 44 and will be published before CMP 16.
- The JISC also welcomed the entry into force of the Doha Amendment to the Kyoto Protocol and, having discussed implications for JI operations, and considering relevant CMP decisions, reflected on the need to understand likely activity levels for JI in respect of the 2nd Kyoto Protocol commitment period.
- The JISC also agreed to undertake a process of information gathering and requested the secretariat to invite Parties with quantified emission reduction or limitation commitments included in the 3<sup>rd</sup> column of Annex B to the KP (as adopted through decision 1/CMP.8) that have ratified the Doha Amendment, to provide an update on their intended JI participation in respect of the 2<sup>nd</sup> commitment period. The secretariat has been contacting the afore-mentioned Parties, requesting an update on their intended participation, with their responses being collated and synthesised in an Information Note for the JISC's consideration at their next meeting on 14 September 2021.
