Report of the 7th meeting of the committee to facilitate implementation and promote compliance referred to in Article 15, paragraph 2, of the Paris Agreement

1. Agenda item 1: Opening of the meeting

- 1. The Co-chairs opened the 7th meeting of the committee to facilitate implementation and promote compliance referred to in Article 15, paragraph 2, of the Paris Agreement by welcoming the members and alternate members of the Committee.
- 2. The members and alternate members of the Committee had agreed to hold the 7th meeting in hybrid format from 10 to 12 May 2022.
- 3. The meeting was held in Bonn at the headquarters of the secretariat.
- 4. The secretariat confirmed that, in accordance with paragraph 15 of the modalities and procedures for the effective operation of the Committee as contained in the annex to decision 20/CMA.1, a sufficient number of committee members were present at the meeting to constitute a quorum.

- 10. The Committee discussed rules 15–18 and 25–27 of the revised Co-Chairs' proposal and made suggestions as to how they might best be refined for the next iteration, to be discussed at the next intersessional informal meeting.
- 11. The Co-Chairs invited the members and alternate members to submit written comments on rules 25–27 of the revised Co-Chairs' proposal by 3 June 2022.

4. Agenda item 4: Information from the secretariat in relation to the submission of reports and communications from Parties to guide the Committee in its functions in accordance with its modalities and procedures

- 12. The secretariat presented information to the Committee relating to the submission of reports and communications from Parties to guide the Committee in its functions in accordance with its modalities and procedures.
- 13. The Committee took note of the information provided by the secretariat, held an exchange of views and agreed to continue its discussion of this item at its next formal meeting.

5. Agenda item 5: Consideration of capacity-building and outreach activities for the biennium 2022–2023

14. The Committee took note of the presentation by the secretariat on possible capacitybuilding and outreach activities for the biennium 2022–2023, agreed with the possible activities presented by the secretariat, as contained in annex 3 to this report, and requested the secretariat to update the online training module "Orientation to the facilitation of implementation and promotion of compliance under the Paris Agreement". The Committee also requested the secretariat's support to organize a side event at COP 27.

15. The Committee agreed to continue to include this item on the agenda for its 8th meeting.

7. Agenda item 7: Other matters

16. The Committee agreed to hold an intersessional informal meeting online from 20 to 21 July 2022 to advance the work on the remaining draft rules of procedure.

- 17. The Committee also agreed to convene its 8th meeting in hybrid format from 9 to 12 August 2022 in Bonn. The Co-Chairs encouraged the members and alternate members of the Committee to attend the meeting in person, to the extent possible, while noting the desirability to retain the option to participate virtually.
- 18. The Committee resolved to call itself the Paris Agreement Implementation and Compliance Committee (PAICC) in its reports and for outreach purposes, and agreed to continue the discussion on how to reflect this matter in its report to the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA).
- 19. The Committee discussed how to consider unsolicited submissions in the light of paragraph 35 of its modalities and procedures, and requested the secretariat to make such submissions available to members and alternate members by placing them on the Committee's internal document-sharing platform.
- 20. The Committee also requested the secretariat to organize a presentation on communicating and maintaining nationally determined contributions (NDCs) in the public registry referred to in Article 4, paragraph 12, of the Paris Agreement at the Committee's next intersessional informal meeting.
