Annotations to the provisional agenda

1. Opening of the meeting

1. The fourteenth meeting of the Paris Agreement Implementation and Compliance Committee² will be opened by the Co-Chairs of the Committee on Tuesday, 15 July 2025.

2. Adoption of the agenda and organization of work

2. In conformity with rule 6 of the rules of procedure of the Committee (decision 24/CMA.4, annex), the Committee will be invited to consider the provisional agenda (document PAICC/2025/M14/P1), annotated in the present document (PAICC/2025/M14/P2), for adoption. The Co-Chairs will present the proposed sequence of discussion for the meeting as per the adopted agenda.³

3. Information from the secretariat in relation to the submission of reports and communications from Parties to guide the Committee in its functions in accordance with its rules of procedure

- 3. The Committee will be invited to consider the most up-to-date information made available by the secretariat pursuant to rules 7 and 18 of the rules of procedure on:
 - a. communication and maintenance of nationally determined contributions (NDCs) by Parties in the public registry referred to in Article 4, paragraph 12, of the Paris Agreement;⁴
 - submissions of mandatory reports or communications of information by Parties under: Article 13, paragraph 7(a) and 7(b) as well as under Article 13, paragraph 9, and Article 9, paragraph 7, of the Paris Agreement;⁵
 - c. participation by Parties in the facilitative, multilateral consideration of progress (FMCP) under Article 13, paragraph 11, of the Paris Agreement;⁶ and

- d. Submissions of mandatory biennial communications of information under Article 9, paragraph 5, of the Paris Agreement.⁷
- 4. The Committee will also be invited to consider relevant information provided in response to the notifications sent to Parties in accordance with rule 20 of the rules of procedure based on the Committee's decisions at its 13th meeting.⁸
- 5. The Committee will further be invited to take any decisions or actions the Committee may wish to take.

4. Consideration of matters relating to gender and Action for Climate Empowerment

- 6. In response to decision 3/CP.25, the Committee is requested to continue to include in its regular reports information on progress towards integrating a gender perspective into its processes.⁹ Further, as part of the Glasgow work programme on Action for Climate Empowerment (ACE), the Committee is invited to include in its regular reports information on how ACE is implemented under its workstreams.¹⁰
- 7. The Committee will be invited to consider a presentation from the secretariat on gender and on ACE. The Committee will further be invited to consider how the goal of gender inclusivity and ACE are implemented under its respective workstreams and how to reflect on it in its annual report.

5. Budgetary and financial matters

8. As agreed by the Committee at its second meeting and in accordance with rule 6, paragraph 2(f), of its rules of procedure, budgetary and financial matters are included as a standing agenda item on the provisional agenda for each meeting. The Committee will be invited to take note of the information presented by the secretariat.

6. Dates and duration of the fifteenth meeting of the Committee

9. In accordance with rule 5 of its rules of procedure, the Committee will be invited to consider and agree upon the dates, duration and venue of its fifteenth meeting based on a proposal from the Co-Chairs. At its 13th meeting, when considering the planning of its activities for the rest of the year, the Committee had expressed its preference to hold its 15th meeting from 29 September to 2 October 2025.¹¹

7. Other matters

10. Any other matters raised during the meeting will be addressed under this agenda item.
