Annotations to the provisional agenda

1. Opening of the meeting

1. The twelfth meeting of the Committee to facilitate implementation and promote compliance referred to in Article 15, paragraph 2, of the Paris Agreement (hereinafter referred to as the Committee) will be opened by the Co-Chairs of the Committee on Monday, 9 September 2024.

2. Adoption of the agenda and organization of work

 In conformity with rule 6 of the rules of procedure of the Committee (decision 24/CMA.4, annex), the Committee will be invited to consider the provisional agenda (document PAICC/2024/M12/P1), annotated in the present document (document PAICC/2024/M12/P2), for adoption. The Co-Chairs will present the sequence of discussion for the meeting as per the adopted agenda.

3. Key developments in the implementation of the 2023-2024 Workplan of the Committee

3. The Committee will be updated on further key developments in the implementation of its 2023-2024 workplan following its 11th meeting from 17–19 April 2024 and, as agreed at that meeting,¹ will be invited to further discuss the recommendations to be included in its fifth annual report to the CMA on the issue of the first review by the CMA of its modalities and procedures (decision 20/CMA.1, annex).

4. Information from the secretariat in relation to the submission of reports and communications from Parties to guide the Committee in its functions in accordance with its rules of procedure

4. The Committee will be invited to consider the most up-to-date information made available by the secretariat pursuant to rule 16 of its rules of procedure (decision 24/CMA.4, annex). Dedicated space has been carved out for further discussions on the submission of nationally determined contributions (NDCs), biennial transparency reports (BTRs) and biennial communications received in accordance with Article 9.5 of the Paris Agreement, in order for the Committee to consolidate its shared knowledge on these mandatory reports or communications of information, in the framework of its upcoming work.

In that context, as agreed at its 11th meeting, the Committee will be invited further to discuss the status of NCDs in the NDC registry,² to test the feasibility of the requested BTR tabular format,³ and build its collective understanding of the submission of biennial communications under Article 9.5 of the Paris Agreement.⁴

6. The Committee will be invited to consider and agree on the dates and times for its meetings in 2025 on the basis of a proposal from the Co-Chairs.

6. Consideration of gender and Actions for Climate Empowerment matters.

7. The Committee will be invited to consider a presentation from the secretariat on the goal of gender inclusivity and Action for Climate Empowerment, and comment, as appropriate.

8. The Committee agreed to have a standing agenda item on budgetary and financial matters at its second meeting and will be invited to take note of the information presented by the secretariat.
