## Annotations to the provisional agenda

#### 1. Opening of the meeting

1. The fifteenth meeting of the Paris Agreement Implementation and Compliance Committee<sup>1</sup> will be opened by the Co-Chairs of the Committee on Monday, 29 September 2025.

#### Adoption of the agenda and organization of work 2.

2. In conformity with rule 6 of the rules of procedure of the Committee (decision 24/CMA.4, annex), the Committee will be invited to consider the provisional agenda (document PAICC/2025/M15/1), annotated in the present document, for adoption. The Co-Chairs will present the proposed sequence of discussion for the meeting as per the adopted agenda.<sup>2</sup>

#### Information from the secretariat in relation to the submission of reports 3. and communications from Parties to guide the Committee in its functions in accordance with its rules of procedure:

#### (a) Information made available pursuant to rule 18 of the rules of procedure

- 3. The Committee will be invited to consider the most up-to-date information made available by the secretariat pursuant to rules 7 and 18, paragraph 1, of the rules of procedure on:
  - a. communication and maintenance of nationally determined contributions (NDCs) by Parties in the public registry referred to in Article 4, paragraph 12, of the Paris Agreement;3
  - b. submissions of mandatory reports or communications of information by Parties under Article 13, paragraph 7(a) and 7(b) as well as under Article 13, paragraph 9, and Article 9, paragraph 7, of the Paris Agreement;4
  - c. participation by Parties in the facilitative, multilateral consideration of progress (FMCP) under Article 13, paragraph 11, of the Paris Agreement;5 and

- d. Submissions of mandatory biennial communications of information under Article 9, paragraph 5, of the Paris Agreement. <sup>6</sup>
- 4. Having considered the information referred to above, the Committee will be invited to take any decisions or actions the Committee deems appropriate, notably relating to any initiation of consideration of issues under paragraph 22(a) of the modalities and procedures,<sup>7</sup> pursuant to rule 18, paragraph 2, of its rules of procedure.

## (b) Information made available pursuant to rule 19 of the rules of procedure

- 5. Further, the Committee will be invited to consider the final technical expert review reports, prepared under Article 13, paragraphs 11–12, of the Paris Agreement and made available to the Committee pursuant to rules 7 and 19, paragraph 1, of its rules of procedure.<sup>8</sup>
- 6. Having considered the information, the Committee will be invited to take any decisions or actions the Committee deems appropriate, notably relating to the identification of cases of significant and persistent inconsistencies of the information submitted by a Party pursuant to Article 13, paragraphs 7 and 9, of the Paris Agreement with the modalities, procedures and guidelines for the enhanced transparency framework (MPGs),<sup>9</sup> for the purposes of paragraph 22(b) of the modalities and procedures, pursuant to rule 19, paragraph 2, of the rules of procedure.

## 4. Consideration of issues and engagement with Parties concerned:

#### (a) Consideration of information provided by Parties concerned

- 7. The Committee will be invited to consider any further information provided by Parties concerned in response to the notifications sent to Parties in accordance with rule 20 of the rules of procedure based on the Committee's decisions at its 13<sup>th</sup> meeting<sup>10</sup> as well as any relevant updates provided by the secretariat.<sup>11</sup>
- 8. The Committee will further be invited to take any decisions or actions the Committee deems appropriate.

#### (b) Consultations with Parties concerned

9. At its 14<sup>th</sup> meeting, the Committee reflected and agreed on how to respond to each of the Parties concerned that had provided information in response to the Committee's notifications and, where consultation with the Committee was requested, how to prepare for those consultations envisaged to take place at its 15<sup>th</sup> meeting.<sup>12</sup> The Committee requested the secretariat to make

arrangements for virtual exchanges with the Parties concerned, where consultation with the Committee was sought, during the Committee's 15<sup>th</sup> meeting to discuss the challenges these Parties face in communicating their NDCs and/or in submitting their BTRs.<sup>13</sup>

- 10. The Committee will be invited to engage with the respective Parties concerned in the virtual exchanges and to consider the information provided by the Parties concerned and any expert advice and additional information sought and received by the Committee from processes, bodies, arrangements and forums under and serving the Paris Agreement, in accordance with paragraphs 25(c) and 35 of the modalities and procedures and rules 10 and 21 of the rules of procedure.
- 11. The Committee will be invited to take any decisions or actions the Committee deems appropriate.

## 5. Consideration of systemic issues

- 12. According to paragraph 32 of the modalities and procedures, the Committee may identify issues of a systemic nature with respect to the implementation of and compliance with the provisions of the Paris Agreement faced by a number of Parties and bring such issues and, as appropriate, any recommendations to the attention of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA) for its consideration.<sup>14</sup>
- 13. At its 13<sup>th</sup> meeting, in view of the large number of Parties that had not communicated an NDC, the Committee acknowledged that there is a potential for identifying issues of a systemic nature and agreed that it will keep this aspect under review, given its function under paragraph 32 of the modalities and procedures.<sup>15</sup>
- 14. At its 14<sup>th</sup> meeting, in view of the significant number of Parties that had not communicated an NDC or submitted mandatory reports and information under Article 13, paragraphs 7 and 9, and Article 9, paragraph 7, of the Paris Agreement, the Committee engaged in an initial consideration of the potential for identifying issues of a systemic nature. It also considered the possibility to bring such issues and, as appropriate, any recommendations to the attention of the CMA and agreed to keep this aspect under review. <sup>16</sup>

### 6. Budgetary and financial matters

15. As agreed by the Committee at its second meeting and in accordance with rule 6, paragraph 2(f), of its rules of procedure, budgetary and financial matters are included as a standing agenda item on the provisional agenda for each meeting. The Committee will be invited to take note of the information presented by the secretariat.
