The 9th Durban Forum on Capacity-building took place on the **5th of June 2020** and was under the theme of "Capacity-building to support the implementation of Enhanced Transparency Framework under the Paris Agreement – ensuring coherence and coordination of actions and support "



Part I: Outcomes of the 9th Durban Forum

Key takeaways from the 9th Durban Forum discussions

- Existing initiatives can play a role in providing long-term support, it is good to build on existing national efforts in developing/strengthening domestic MRV systems.
- Capacity-building efforts must ensure systems capacity is built by investing in and leveraging existing institutions.
- Overlaps exist between the requirements of BUR and BTR. Thus, technical knowledge and institutional arrangements developed under the existing arrangements can help developing countries prepare for future reporting under the ETF.
- Some areas that require capacity-building include:
 - ✓ GHG inventory data management systems,
 - ✓ Strengthening institutional arrangements,
 - ✓ localized impacts for better projections/modeling.



Key takeaways from the 9th Durban Forum discussions

- "MRV Hubs" at regional/sub-regional level to share expertise and support the development and enhancement of capacities.
- PCCB, with its convening power, is excellent for flagging Capacity-building needs, and has set up good initiatives including:
 - ✓ Capacity building-Hub and,
 - ✓ PCCB network.
- The PCCB's works on enhancing coherence and coordination of capacity-building through coordinating with other bodies such as SCF or CGE could also add value.
- South-South cooperation as an effective approach to enhancing national capacity, as it allows other countries to save resources by sharing lessons learned, and to replicate experiences that have already achieved results quickly.

In 2019, the PCCB considered a technical paper based on the results of a PCCB pilot exercise to capture national capacity-building needs and gaps as well as on success factors, good practices and lessons learned with regard to closing existing capacity gaps in developing countries for the implementation of the Paris Agreement.



Among the recommendations of the technical paper was that the PCCB be directed to develop a toolkit which can guide developing country Parties' assessment of capacity gaps and needs relating to the implementation of the Paris Agreement.



The concept note (Document **PCCB/2020/4**) provides an overview of factors that could be considered by the PCCB in the development of a toolkit to support these developing country Parties' assessments and is intended to form part of the PCCB's 2021-2024 workplan to be considered by COP 26.



Three key considerations for discussion and decision:

- Scope: The toolkit could capture elements of one or both of the following designs:
 - A toolkit containing relevant selected tools for assessing capacity needs and gaps related to implementing the Paris Agreement, including entry points to the assessment and guidance on how to apply the tools;
 - A simple collection of external resources providing centralized information on best practices and lessons learned on capacity needs assessment targeted to officials engaged in capacity-building.
- Approach: Mindful of target audience and their priorities, needs and constraints. Options:
 - Offer step-by-step guidance
 - Bottom-up approach
 - Adopt a sector-based approach
- Format: Depending on the scope and approach, format could include one or a mix of the following elements:
 - Report format
 - interactive or module-based format,
 - based on case studies disseminated through, for example, the Capacity-building Portal

Part I: Concept note on establishing an informal coordination mechanism on capacity-building under the Convention

Background

Document PCCB/2020/5



In 2019, the PCCB produced a **technical paper** entitled 'Coherence and coordination of capacity-building activities of constituted bodies and in other relevant processes under the Convention that analysed gaps in coherence and coordination practices across the capacitybuilding'

The paper identified the need for an enhanced space for coordination and collaboration outside the annual meetings of the PCCB, and for defining common areas of interest which would help increase synergies and reduce duplication of efforts.



In response to these needs, the notion of an ICM was discussed intersessionally by PCCB members and a concept note (Document **PCCB/2020/5**) has been developed for consideration and discussion at the 4th meeting of the PCCB.



Part I: Alignment with PCCB priority areas defined by COP 25

Document PCCB/2020/5

- ICM aligns with the priority areas of the PCCB (decision 9/CP 25, paragraph 9)
- A stepwise approach to supporting the implementation of the first priority area, "enhancing coherence and coordination of capacitybuilding under the Convention with a focus on avoiding duplication of efforts, including through collaboration with bodies under and outside the Convention".
- The second priority area, which focuses on identification of gaps and needs, relies on the ICM for critical input as to how ICM members address gaps and needs in their work.
- The third priority area, focusing on stakeholder engagement, relies on inputs from the ICM, including on gaps and needs and disseminating them through PCCB communication channels.

Action 2: Issues related to the launch and implementation of the PCCB Network

- vii. **Engagement**: prioritizing activities that engage multiple Network members and reach a wide range of stakeholders/audiences.

Action 2: Proposed draft criteria for the participation of external stakeholders in PCCB working groups

The PCCB may wish to consider the following criteria for the participation of external experts in PCCB working groups. More detail on these is available in Document PCCB/2020/8.

(a) **Identification of external experts:** The PCCB may wish to draw expertise from PCCB Network members, on the basis of members' areas of focus and expertise. If the expertise required by the working groups is not available within the PCCB Network, the PCCB may seek expertise from external entities or initiatives.

(b) **Engagement of external experts**: Participation in the working groups may take different forms and be subject to different modalities, depending on the needs of the working group in question: (1) ad-hoc engagement, (2) activity-based, (3) thematic-based.

(c) Membership of external members: For the next workplan period, the PCCB may wish to invite external experts to join the working groups on an activity-based or thematic-based basis for an initial term of one year, with the possibility of a one-year extension. Working groups are encouraged to engage with any number of external experts on an ad-hoc basis, as appropriate.

(d) Working arrangements: It is planned that external members will be involved in the intersessional work of working groups through virtual means.

(e) Decision-making: Proposals concerning the participation of an external expert in a working group will be approved by the PCCB. External members shall be accorded the right to speak at all times during meetings of the working groups or the PCCB, but shall abstain from decision-making by the working group or the PCCB.

(f) Communication modalities: The working group leads are the primary points of contact for external experts wishing to submit queries. The working group leads should keep all PCCB members informed about updates on the engagement of external experts intersessionally.

One of the flagship activities of the PCCB is the Capacity-building Hub, a series of capacity-building-related sessions that focus on different themes, typically over the course of a week, in conjunction with sessions of the COP. Focus area of the Paris Committee on Capacity-Building for 2021

Background

COP 21 decided that the PCCB will annually focus on an area or theme related to enhanced technical exchange on capacity-building. The PCCB may wish to agree on its specific focus area of work for 2021 with a view to including information thereon in its annual technical progress report.

Consider and discuss the options for its 2021 focus area and the proposed implementation approach contained in PCCB/2020/10;



Agree on the 2021 focus area at the 4th meeting of the PCCB or intersessionally;



Agree on the approach that it will take to implement its focus area in the next workplan period



Document PCCB/2020/10

The PCCB may wish to consider and discuss the following options for its 2021 focus area, which were all determined on the basis of previous work performed by the PCCB. More detail on these is available in Document **PCCB/2020/10**.



(a) Building capacity to facilitate the coherent implementation of nationally determined contributions (NDCs) and the Sustainable Development Goals (SDGs).

(b) Enhancing the monitoring and evaluation of capacity-building activities.



(c) Increasing climate ambition through capacity-building among youth and educators.



Option 1:

Building capacity to facilitate the coherent implementation of NDCs and SDGs

Background:

- To foster coherence, an enhanced understanding of the connections between climate change and sustainable development is required
- Launch of the **UN Decade on Ecosystem Restoration** (2021–2030) would make 2021 a compelling year to highlight the need for coherence in NDC-SDG implementation

Possible role of the PCCB:

- Use its strong mandate to engage with other bodies under and outside the Convention to promote coherence in achieving Paris Agreement objectives and fulfilling the SDGs
- Help build **sector-relevant capacity** for **SDG-NDC mainstreaming**, as well as build capacity to align NDC implementation with the SDGs at the sectoral and local level
- Collaborate with actors which have already defined common objectives in order to provide countries with integrated support for joint SDG–NDC mainstreaming, SDG– NDC screening of existing development plans, and capacity-building
- Help Parties to learn from **each other's approaches** to policy planning, budgeting, monitoring and reporting
- Promote greater awareness and knowledge of feasible ways to utilize potential synergies, thereby fostering more ambitious climate action across multiple stakeholder groups and increasing the ambition of future NDCs



Option 2:

Enhancing the monitoring and evaluation of capacity-building activities

Background:

- Given the lack of agreed indicators, metrics and tools, Parties are struggling to regularly track and evaluate their capacity-building activities.
- Stakeholders engaged in the UNFCCC process have highlighted this as a key area for improvement for capacity-building activities.
- Stakeholders, including the European Capacity Building Initiative and the World Resources Institute have suggested that the PCCB is key to supporting this work.

Possible role of the PCCB:

- Build on the discussions on this topic initiated at the recent meetings of the Durban Forum to promote technical exchanges, and gather and **disseminate best practices** and available tools or methodologies for **assessing the impact and effectiveness** of capacity-building activities.
- Based on this work, contribute to a **compendium of good practices** for monitoring and evaluating capacity-building activities to support the work performed under the Convention and the Paris Agreement.
- Promote **well-developed**, **well-applied metrics** to help to enhance understanding of the key factors in successful capacity-building and to measure progress, thereby also contributing to measuring progress under the Global Stocktake.



Option 3: Increasing climate ambition through capacity-building among youth and educators

Background:

- Education (both formal and informal) contributes to institutional capacity-building in both the short and the long term and supports human resource development
- While academic institutions play a central role in climate change related capacitybuilding, concerted efforts are needed from multiple stakeholder groups, including the youth
- Young people are key actors in tackling climate change and are involved in a broad range of activities, ranging from raising awareness of climate change issues

Possible role of the PCCB:

- Intensify **collaboration** with educators such as universities and university networks, research and independent and youth non-governmental organizations, and other actors involved in Action for Climate Empowerment (ACE)
- Facilitate technical discussions, highlight evidence-based case studies and enable and promote the exchange of best practices and lessons learned to support efforts to empower youth, academics and other educators to raise climate ambition at the local and national level through enhanced, long-term capacity-building
- Build on the relevant discussions and findings from the 2019–2020 series of PCCB Capacity-building **Knowledge to Action Days** at the regional and COP level, as well as on previous PCCB activities conducted in support of issues of youth and elements of ACE



In line with document **PCCB/2020/10**, the draft PCCB workplan for 2021–2024 (see document **PCCB/2020/3**, **Activities C.1.2 and C.2.3**) sets out a cross-fertilization approach, creating an interchange between discussions at the annual Durban Forum (DF), which is thematically aligned with the annual PCCB focus area, and the annual work of the PCCB related to the focus area.

The PCCB may wish to consider the proposed approach:

- PCCB actively participates in the DF, including, as appropriate, as resource persons;
- The key messages of the DF are discussed at the annual PCCB meeting with a view to translating key DF findings into recommendations to COP and the CMA and other stakeholders, as appropriate;
- In the second half of each year, the PCCB organizes one or more webinars to discuss the topic or selected subtopics of the DF in more detail, which it could hold as part of its PCCB Network webinars, offering Network members the opportunity to (co)host the webinars.
- PCCB could also consider organizing a set of regional webinars in order to obtain regionspecific findings;
- PCCB organizes a dedicated focus area day at the annual Capacity-building Hub at the COP.
