# **Draft decision -/CP.29**

# Poznan strategic programme on technology transfer

The Conference of the Parties,

Recalling decisions 2/CP.14 and 1/CP.27, paragraph 46,

- 1. Welcomes the financial support provided by the Global Environment Facility under the Poznan strategic programme on technology transfer, including for undertaking technology needs assessments, supporting the regional climate technology transfer and finance centres and piloting priority technology projects aimed at scaling up the level of investment in technology transfer;
- 2. Also welcomes the information provided by the Global Environment Facility on the Poznan strategic programme in its annual reports to the Conference of the Parties and looks forward to the finalization in 2026 of the terminal evaluation reports on the regional climate technology transfer and finance centres in Africa, and Europe and Central Asia respectively, as referred to in the annual report of the Global Environment Facility to the Conference of the Parties for 2024;
- 2.bis Requests the Technology Executive Committee to prepare, with the support of the secretariat and in collaboration with the Global Environment Facility, an updated report on the evaluation of the Poznan strategic programme<sup>2</sup> upon completion of the outstanding projects under the programme;
- [3. Requests the secretariat to prepare an updated synthesis report on technology needs assessments on the basis of information in the technology needs assessment reports submitted as at 31 December 2024, prepared with support provided under phases III–IV of the Global Technology Needs Assessments Project taking into account the terminal evaluations of phases I–III of the project, as well as prepared with support of the Green Climate Fund and the Climate Technology Centre and Network, for consideration by the Subsidiary Body for Scientific and Technological Advice at its sixty-third session (November 2025);]
- 4. Acknowledges the need for enhanced access to financial and capacity-building support for developing countries, in particular the least developed countries and small island developing States, for implementing and scaling up prioritized technology measures, including those identified in technology needs assessments and technology action plans;

5. Decides to conclude consideration of the Poznan strategic programme and encourages the Global Environment Facility, the Green Climate Fund, the Technology Executive Committee and the Climate Technology Centre and Network to consider successes, challenges and lessons learned related to implementing the Poznan strategic programme with a view to strengthening their support for the implementation of technology priorities identified by developing countries;

# Option 2

5. Requests the SBI to consider the Poznan strategic programme at its session immediately following the operationalization of the technology implementation programme with a view to concluding consideration of the matter and agrees that successes, challenges and lessons learned related to implementing the Poznan strategic programme should be taken into consideration in implementing the technology implementation programme;

# Option 3

- 5. Requests the Global Environment Facility, taking into account successes, challenges and lessons learned related to implementing the Poznan strategic programme, to develop a new phase of the programme focused on implementing the outcomes of the Poznan strategic programme with a view to facilitating the transition from pilot to large-scale technology projects and enabling the implementation of outcomes of technology needs assessments;
- 6. Takes note of the estimated budgetary implications of the activity [ies] to be undertaken by the secretariat referred to in paragraphs 2bis [and 3] above;
- 7. *Requests* that the action[s] of the secretariat called for in this decision be undertaken subject to the availability of financial resources.
