

She is currently spearheading the work on Nationally Determined Contributions (NDCs) and gender equality and social inclusion, including the work with Indigenous Peoples and Youth, supported by the Climate Strategies and Policy Team and the Climate Promise initiative. Previously, she worked as a Policy Specialist for Environment and Climate Change in the UNDP Gender Team at Headquarters. She also oversaw the environment, energy, and climate change portfolio in UNDP's country office in Mexico, where she worked with national and subnational

governments, civil society organizations, and at the community level. Verania holds an MSc in Environment and Development from the London School of Economics and Political Science.



Verona Collantes-Lebale, Senior Gender Specialist, Global Environment Facility

Verona reviews programs submitted for GEF funding to ensure compliance with GEF's gender equality policy requirements. She leads the preparation of knowledge products, including best practices in gender mainstreaming, as well as reports to the GEF Council and the Conventions on progress in gender equality in GEF programming. She contributes to raising the visibility of gender issues in the thematic areas of the GEF through her participation in meetings of the Conventions, regional and national discussions and expert meetings.

Verona convenes the GEF Gender Partnership (GGP), whose members include gender focal points of the 18

implementing agencies of the GEF and the 5 Secretariats of the Conventions that the GEF serves, and actively engages with women's organizations and youth networks. The GEF Gender Partnership is a powerful platform for knowledge exchange, capacity-building and communicating impacts among GGP members and vis-à-vis external partners.

Before joining the GEF, Verona was an Intergovernmental Specialist at the United Nations Entity for Gender Equality and the Empowerment of Women (UN Women) and served various position in UN agencies in New York and Geneva, Switzerland. She was a Philippine Foreign Service Officer. Verona completed her Masters in International Law and Economics at the World Trade Institute in Bern, Switzerland.



Tiffany Hodgson, Head of Sustainability and Inclusion, Green Climate Fund

Tiffany Hodgson is Head of Sustainability and Inclusion, leading the Office of Sustainability and Inclusion (OSI). She was formerly the Manager of Environmental and Social Safeguards, Gender and Indigenous Peoples matters in the Office of Risk Management and Compliance. Prior to joining the GCF in April 2021, Tiffany worked at the United Nations Climate Change Secretariat, where she led the team that supported the Local Communities and Indigenous Peoples Platform. During her time at the UNFCCC, she also worked on climate change adaptation, the long-term global goal, and climate finance; and served as a focal point on gender. Prior to that, Tiffany worked in her home country of South Africa at the Centre for Policy Studies.

She holds an Honours Degree in Politics from the University of Johannesburg and a Master of Science degree, focused on environmental sciences.
