


Why does climate change matter for the labour market?



Climate change impacts on jobs and productivity


- Annually, 23 million working life years have been lost due to disasters induced or enhanced by human activity.
- By 2030, 2% of working hours will be too hot to work, owing to climate change.
- 1.2 billion jobs are closely linked to eco-system services






Climate change impacts on jobs and productivity

- Baseline: 1.2 billion jobs are closely linked to eco-system services.
- Inaction: By 2030, 2% of working hours can be lost, with decline to labour productivity.
- Action: Achieving the 2-degree target brings net employment gains of 18 million new jobs by 2030.





The low-carbon economy example: Net job gain, with regional disparities



18 million net job gain with the implementation of the Paris Agreement in the energy sector

- Achieving the 2-degree target brings net employment gains of 18 million new jobs.
- Some world regions will see job creation, others loss of employment.
- Important reallocation:
- Away from fossil fuels towards renewables
- Within the mining and manufacturing sector towards inputs for inputs for electric vehicles ' and electrical machinery




What are 'Green Jobs'

Green jobs are <u>decent jobs</u> either in traditional but also in emerging 'green' sectors or service that:

- Reduce consumption of energy and raw materials
- Limit green house gas emissions
- Minimize waste and pollution
- Protect and restore ecosystems
- Help adapting to climate change

Green jobs are a vehicle to securing a just transition through win-wins



Advancing social justice, promoting decent work



Just Transition to environmentally sustainable economies and societies for all

A Just transition aims to maximize climate action and minimize negative social impacts of a green transition, while maximising opportunities.

Planning for a just transition has clear positive impact on the labour market including

- Job and income gains are maximized
- Risks of job and income losses are minimised and addressed
- ► The vulnerable are protected and included

Economies have lower emissions and climate change vulnerability



Quality jobs increase and social justice advanced





What is a Just Transition?


Just transition key elements

- The concept of just transition was originally a labour union framework. Since 2015 the ILO Just Transition Guidelines have aligned government, workers and employers on the agenda.
- Social dialogue
- **Planning** for a transition framework and greening of the economy
- Economic and growth policies coupled with skills development, OHS, social protection, active labour market policies and labour rights





Mission and Vision

The Initiative will **boost climate action** by ensuring that **people's jobs** and **well-being** are at the centre of the transition to a carbon-neutral and climate-resilient economy.

As a multistakeholder alliance, the Initiative aims to

Enable ambitious climate action that delivers decent jobs and advances social justice. Support countries on **bold solutions** for a transition towards a **sustainable future** that is just and enjoys broad-based support. Facilitate an inclusive and sustainable **recovery** from the **COVID-19 crisis**.



Demand-driven Country support: levels of intervention

3 Levels of Intervention

I. Overarching framework interventions

Assist countries on overarching policy and planning instruments for a just transition that cut across policy fields and on mechanisms for social dialogue based on specific country contexts.

II. Sectoral and thematic policy interventions

Support countries to **assess** and **address gaps**, such as in employment, skills development and social protection measures, as well as constraints to job-rich growth **in key green sectors**, and assist **policy development** and **reform**.

III. Programmatic interventions

Provide technical assistance on the design and delivery of operational programmes and schemes to implement policies, and facilitate linkages with financing mechanisms. They build on the sectoral and thematic policy framework interventions, and research from the innovation facility.

Contributing to UN Sustainable Development Cooperation Frameworks and UN Country Programmes, and Decent Work Country Programmes





Green Jobs in Algeria (ongoing)


- Green Business Assesment model
- Rapid asessment of green growth sectors
- Market sistem analysis of selected sector
- Skills gap analysis of selected sectors and support to TVET institutions to adapt their curricula according to market needs
- Identification of (micro) business opportunities and piloting Entrepreneurship development interventions with business development providers (public institutions)





Decent Jobs for Egypt Young People (DJEP)

- Emphasis on green jobs creation at both the national and local level in three governorates of Minya, Port Said and the Red Sea.
- Interventions have helped to create awareness and dialogue on the potential benefits of green jobs across several sectors in Egypt.
- Skills development for Green Jobs in Egypt report
- Promotion of microenterprise development programme in waste management sector, agriculture and renewable energy using SIYB (adapted to the Egyptian context)
- Create Green Jobs through Green Tourism The Green Start Hotel Certification Programme for Hotels in the Red Sea"
