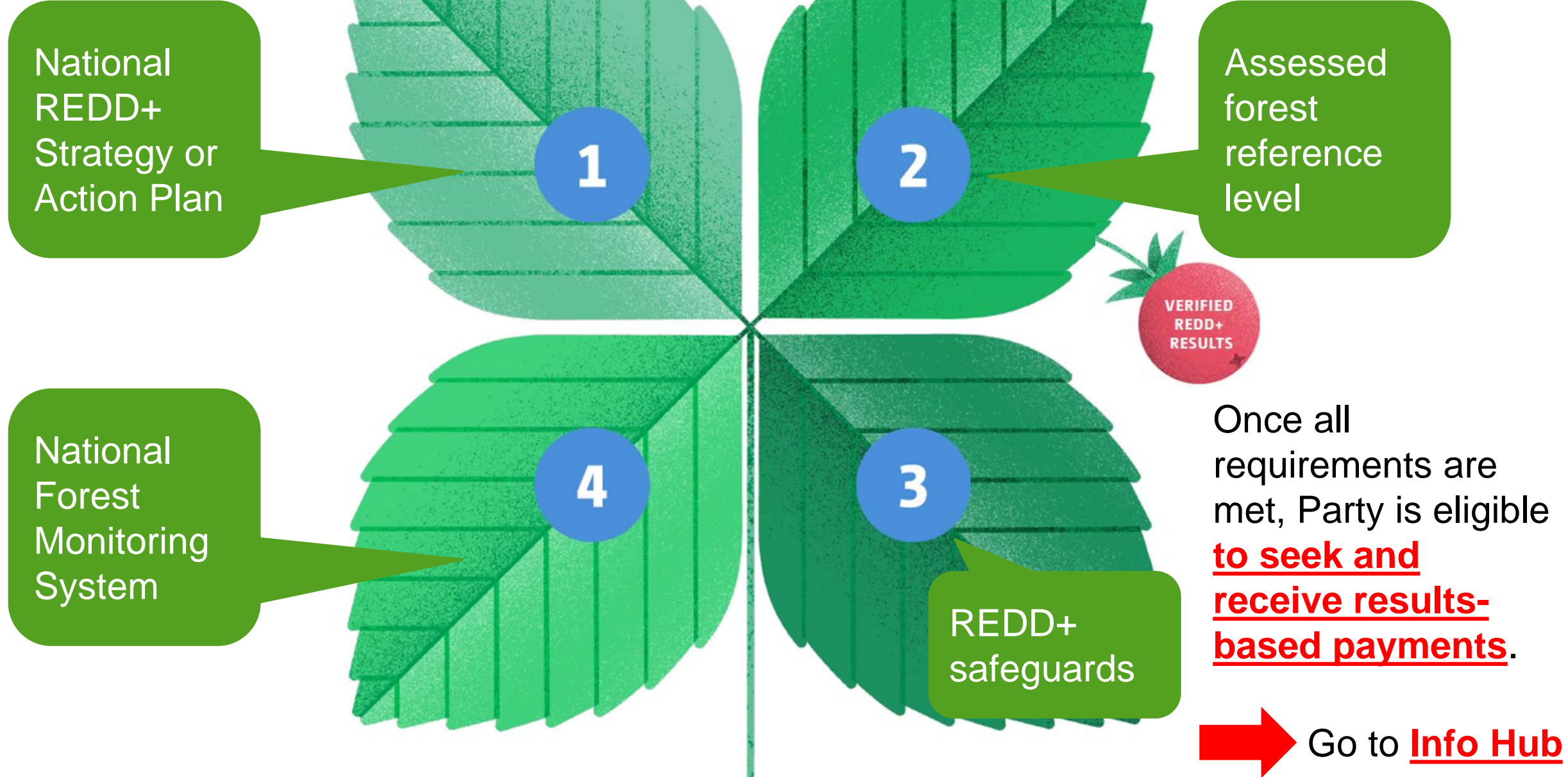

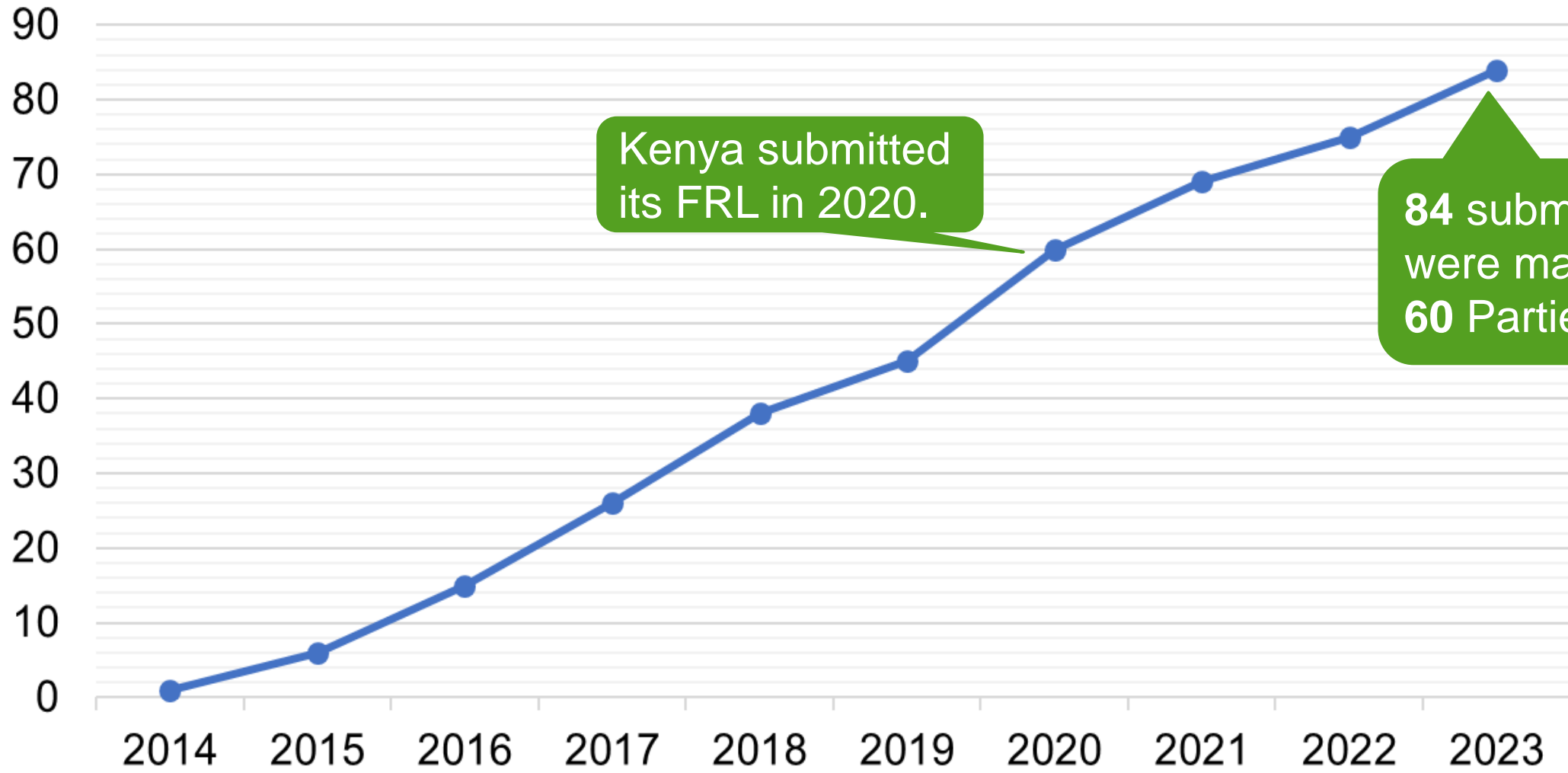

FREL/FRL submissions (cumulative total)



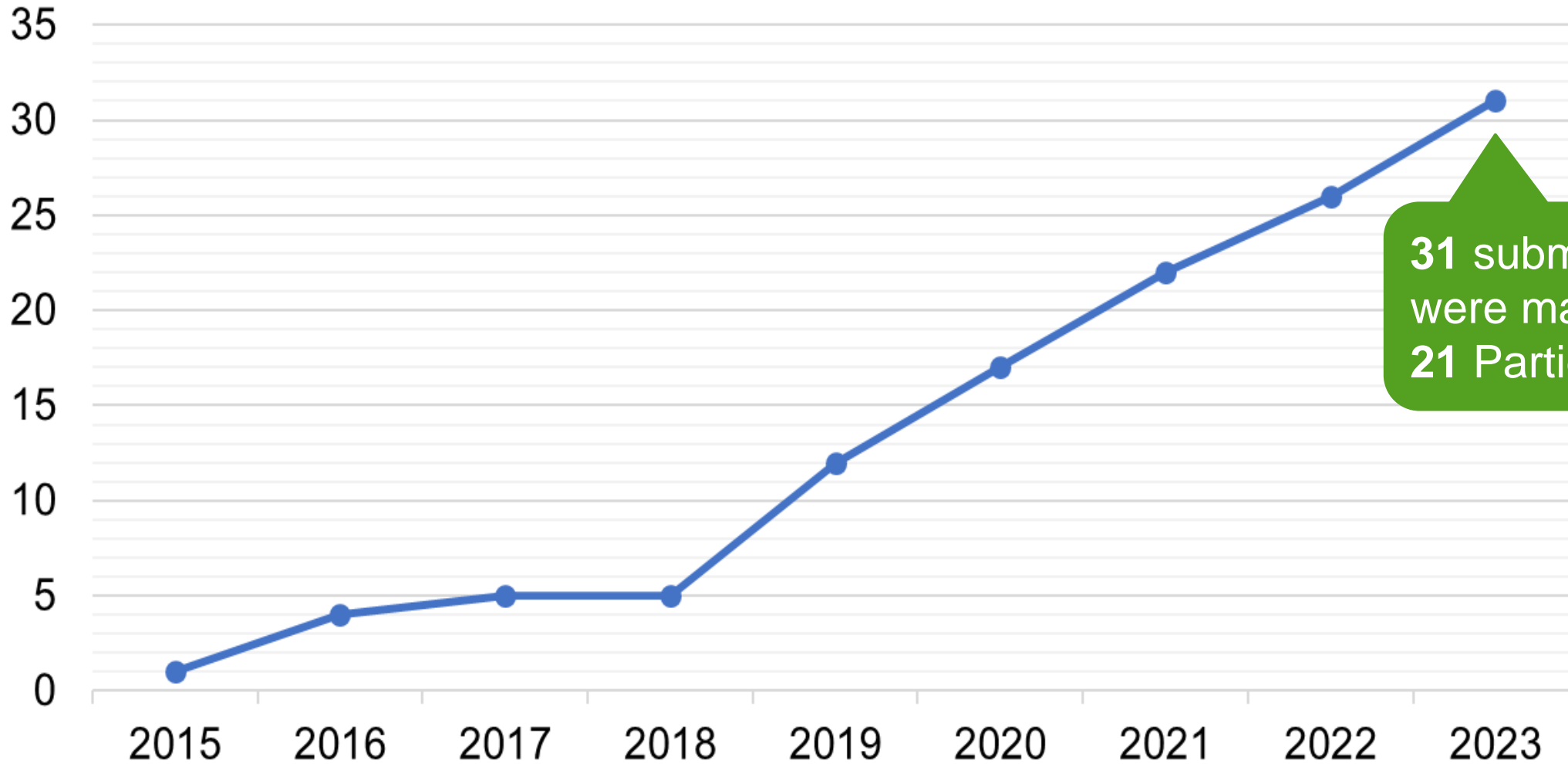
Kenya submitted its FRL in 2020.

REDD+ results data

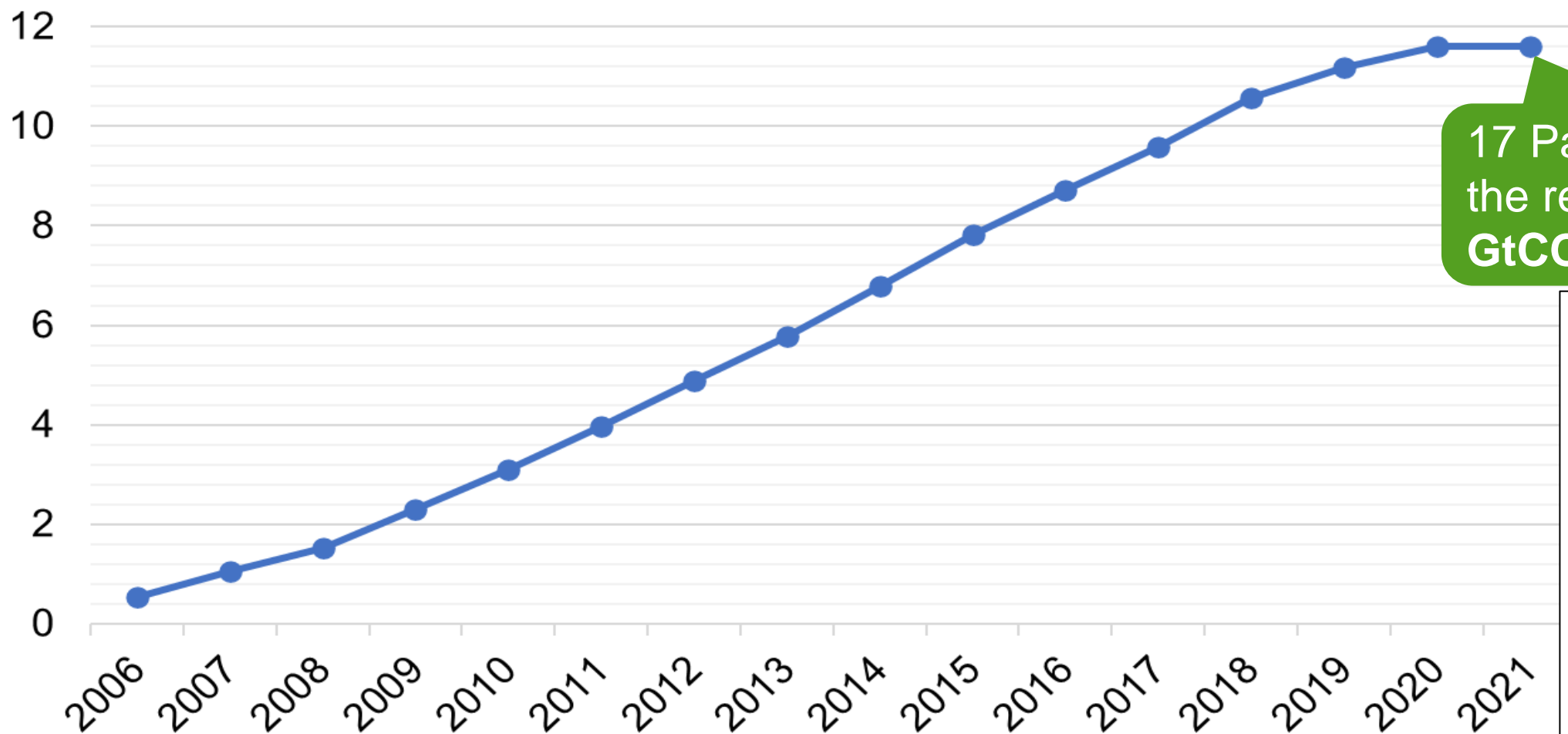


REDD+ results submissions (cumulative total)

Article 5 of the Paris Agreement

1. Parties should take action to conserve and enhance, as appropriate, sinks and reservoirs of greenhouse gases as referred to in Article 4, paragraph 1(d), of the Convention, including **forests**.
2. Parties are encouraged to take action to implement and support, including through **results-based payments**, the **existing framework** as set out in related guidance and decisions already agreed under the Convention for: **policy approaches and positive incentives for activities relating to reducing emissions from deforestation and forest degradation, and the role of conservation, sustainable management of forests and enhancement of forest carbon stocks in developing countries**; and alternative policy approaches, such as joint mitigation and adaptation approaches for the integral and sustainable management of forests, while reaffirming the importance of incentivizing, as appropriate, non-carbon benefits associated with such approaches.

- **Sends a strong political signal on the importance of ecosystems, in particular forests,** in implementing the Paris Agreement
- Reassures Parties and other stakeholders that the implementation of existing climate change mitigation approaches in the forest sector **using the REDD+ framework** is encouraged and recognized
- Limited operational implications for the on-going activities

Decision 1/CP.24

- 45. Decides that the technical annex referred to in decision 14/CP.19, paragraph 7, containing modalities for measuring, reporting and verifying the activities referred to in decision 1/CP.16, paragraph 70, shall be submitted as an annex to the biennial transparency report;
- 46. Also decides that the technical analysis referred to in decision 14/CP.19, paragraph 11, containing modalities for measuring, reporting and verifying the activities referred to in decision 1/CP.16, paragraph 70, shall be carried out **concurrently** with the technical expert review under Article 13 of the Paris Agreement;

- Article 5 of the Paris Agreement recognizes the **key role of forests and REDD+ for addressing climate change** at treaty-level
- **Transparency of action and support** is a must for trust-building and for tracking of progress.
- The measurement, reporting and verification for REDD+ links with **GHG reporting including tracking NDCs** and Article 6, enhancing capacity towards Paris Agreement implementation, enhanced ambition and progressing towards multiple national goals
