Mobilizing Investment for Resilient and Low Emission Agrifood Systems in Asia through Carbon Markets

Regional Workshop

Dates: 16-18 September 2024

Venue: JW Marriott Hotel, 4 Sukhumvit Road Soi 2, Bangkok, Thailand

Background and context

The first-ever global stocktake (GST), a key part of the Paris Agreement's ambition ratcheting mechanism, was central to the United Nations Framework Convention on Climate Change (UNFCCC) 28th Conference of Parties (COP 28) in 2023. In Dubai, the GST negotiating text recognized the importance of safeguarding food security and the paramount role of agrifood systems in addressing climate change. Nevertheless, food was only mentioned in the GST preamble and adaptation section, and was not featured in the mitigation section, indicating that little progress has been made on mitigation in agrifood systems. The GST text also noted that full implementation of the latest Nationally Determined Contributions (NDCs) puts the world on track for a global temperature increase in the range of 2.1 to 2.8°C, indicating that significantly greater emissions reductions are required.

Article 6 of the Paris Agreement, a global mechanism to attract private investment and encourage voluntary cooperation among Parties, can offer significant benefits to bridging the substantial emissions gap and financial gap. It is estimated that employing Article 6 cooperation to achieve NDCs may save over US\$300 billion per year in 2030 compared to independent NDC implementation by individual countries. If those savings were reinvested, emissions mitigation could be more than doubled.

The Food and Agriculture Organization of the United Nations (FAO) is implementing a Technical Cooperation Programme entitled, *"Strengthening capacity of policy makers to mobilize investment for resilient and low emission agrifood systems in Asia under Article 6 of the UNFCCC Paris Agreement,"* in which Cambodia, Philippines, Thailand and Viet Nam are participating. Under this programme, FAO in partnership with the Institute for Global Environmental Strategies (IGES) and development partners are organizing a regional workshop to discuss opportunities created by Article 6 and voluntary carbon markets (VCMs) for raising NDC

ambition and closing financing gaps to implement NDCs and Long-Term Strategies (LTS). The workshop will engage other countries in the region as well and facilitate discussion of challenges faced by agrifood system stakeholders in accessing carbon markets. Further, it will explore country-specific approaches for developing Article 6 and VCM mitigation opportunities to unlock carbon finance for agrifood systems and enhance preparedness for participating in Article 6 and VCMs.

Objective

The workshop will empower stakeholders' participation in carbon markets by illustrating countryspecific approaches for development of Article 6 and VCM opportunities to unlock carbon finance for agrifood systems; showcasing progress and gaps in carbon market readiness; and providing deep-dive capacity building training on key topics relevant for agrifood system stakeholders. Outcomes from the workshop will inform development of national readiness roadmaps for agrifood systems and Article 6 participation.

Outcomes

- Improved awareness of the mitigation opportunities created by Article 6 and VCMs to unlock carbon finance for agrifood systems.
- Shared experience of agrifood system stakeholders in carbon markets, including challenges and solutions to mobilize finance and capacity building needs to empower stakeholders in carbon market participation.
- Collective insights for the development of national readiness roadmaps for agrifood systems and Article 6 participation.

Expected participants

- Government focal points from Cambodia, India, Indonesia, Philippines, Thailand, Viet Nam and other countries, including representatives from Ministries of Agriculture, Ministries of Environment and national greenhouse gas (GHG) registries.
