Fifth meeting of the informal coordination group for capacity-building under the Convention and the Paris Agreement

I. Context

In line with the workplan of the Paris Committee on Capacity-building (PCCB) for 2021-2024¹ the informal coordination group for capacity-building under the Convention and the Paris Agreement (ICG) was established in early 2021. The ICG currently meets twice per year on the margins of existing sessions. This concept note outlines a provisional agenda for the fifth meeting of the ICG.

II. Objective of the ICG

The purpose of the ICG is to create a conducive space for representatives of constituted bodies, operating entities and relevant processes under the Convention and the Paris Agreement to coordinate climate change related capacity-building plans and activities, and allow for better sharing of information, coherence, and identification of opportunities.²

III. Description

The fifth ICG meeting will be held on the margins of SBI 58 in Bonn, Germany in June 2023. Virtual participation will be enabled via MS Teams, especially for those ICG members who are not attending the SB sessions.

Anticipated participants include PCCB co-chairs, members of PCCB working group 1, and ICG members, including, nominated representatives of the Adaptation Committee, Adaptation Fund Board secretariat, Consultative Group of Experts, Climate Technology Centre and Network, Executive Committee of the Warsaw International Mechanism for Loss and Damage, Facilitative Working Group of the Local Communities and Indigenous Peoples Platform, Global Environment Facility secretariat, Green Climate Fund secretariat, Katowice Committee of Experts on the Impacts of the Implementation of Response Measures, Least Developed Countries Expert Group, Nairobi Work Programme, Standing Committee on Finance, Technology Executive Committee, and representatives of the Action for Climate Empowerment process and the Lima Work Programme on Gender.
