Annotations to the provisional agenda

1. Opening of the meeting

1. The 38th meeting of the enforcement branch of the Compliance Committee of the Kyoto Protocol will be opened by the chairperson of the branch.

2. Round of introduction of members and alternate members of the enforcement branch

2. Members and alternate members of the branch will be invited to introduce themselves briefly.

3. Adoption of the agenda and organization of work

3. In conformity with rule 7 of the rules of procedure of the Committee¹, the branch will be invited to consider and adopt the provisional agenda for this meeting, annotated in the present document (document CC/EB/38/2023/1).

4. The branch will also be invited to consider the indicative schedule to conduct its work, as presented by the chairperson of the branch, for agreement.

4. Consideration of the questions of implementation with respect to Kazakhstan

5. At its 37th meeting, the branch considered the third progress report and an advance copy of the fourth progress report submitted by Kazakhstan² in accordance with paragraph 29 of the preliminary finding³ and paragraph 6 of the final decision⁴. The branch noted that it looked forward to receiving additional information from Kazakhstan, including information in subsequent progress reports to be considered at its 38th session⁵. Kazakhstan submitted its fifth progress report⁶ on 18 July 2023.

6. The branch will be invited to consider a presentation by the secretariat summarizing the current status regarding the questions of implementation with respect to Kazakhstan⁷, including advice on the questions of implementation with respect to Kazakhstan that are not dependent on its acceptance of the Doha Amendment.

7. The branch will also be invited to consider a presentation by Kazakhstan and to deliberate on how to proceed with the reviews of the plans and any adoption of the decision on the plans.
