Annotations to the provisional agenda

1. Opening of the meeting

1. The 25th meeting of the facilitative branch of the Compliance Committee of the Kyoto Protocol will be opened by the chairperson of the branch.

2. Members and alternate members of the branch will be invited to introduce themselves briefly.

3. In conformity with rule 7 of the rules of procedure of the Committee¹, the branch will be invited to consider and adopt the provisional agenda for this meeting, annotated in the present document (document CC/FB/25/2022/1).

4. The branch will also be invited to consider the indicative schedule to conduct its work, as presented by the chairperson of the branch, for agreement.

4. Provisions related to facilitation: Advice and facilitation

5. In accordance with section VI, paragraph 3 of the procedures and mechanisms relating to compliance under the Kyoto Protocol², and paragraph 49 of the Guidelines for review under Article 8 of the Kyoto Protocol³, the secretariat forwards the reports on the individual reviews of the annual submissions by Parties (ARRs) to the Committee as published. At its 24th meeting, the branch agreed to continue the review of the 2020 and 2021 ARR in the context of its overall mandate and functions⁴.

6. The branch will be invited to consider the outcomes of the review of ARR conducted by some members and alternate members, as well as the experience gained in reviewing ARR, and agree upon the working arrangements to review the remaining ARR in preparation for its 26th meeting.

7. At its 24th meeting⁵, the branch decided to update the document *Experience of the facilitative branch of the Kyoto Protocol Compliance Committee in providing advice and facilitation to Parties in implementing the Kyoto Protocol*⁶. The branch will be invited to consider a presentation by the secretariat on the possible approach to conducting this update and agree upon the next steps.
