4. Consideration of matters relating to gender and Action for Climate Empowerment

- 5. The plenary will be invited to consider a presentation from the secretariat on matters relating to gender and Action for Climate Empowerment (ACE). In accordance with the enhanced Lima work programme on gender and its gender action plan,² the plenary will be invited to reflect on its efforts of integrating a gender perspective into its processes and consider how in include information on progress in that regard in its annual report to the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP).³
- 6. In addition, the plenary will be invited to reflect on how ACE and its six elements education, training, public awareness, public participation, public access to information and international cooperation on climate change can be promoted and how it is integrated under its workstreams, in light of the Glasgow work programme on ACE and its action plan.⁴
