### Welcome readers to the world of climate actions! We hope you are staying safe during this extraordinary time.

The 30<sup>th</sup> July marked the cut-off date for the submission of new or updated nationally determined contributions (*NDCs*) to be included in a synthesis report that will be issued later this year, ahead of COP26. The IPCC's update on the physical science basis of climate change, published in the beginning of this month, clearly reminds us that the level of ambition reflected in those national climate action plans still needs to be enhanced.

Countries can, of course, continue to enhance the ambition of their respective NDCs. If needed, an update of the report's key findings may eventually be prepared to take account of information received after 30 July.

Some encouraging news from the region include submission of the Indonesian Long-term Strategy for Low Carbon and Climate Resilience 2050 (LTS-LCCR 2050) on 22 July 2021, last month's submission of Samoa's 2nd NDC and updated NDC submission by Indonesia, Solomon Islands, Malaysia and Sri Lanka. A climate warning that shouldn't go unnoticed - deadly floods have upended life in both China and Germany. <u>Climate-proof housing</u> and infrastructure will be expensive, but the cost of inaction is higher. As highlighted in the recent <u>IPCC report</u> and by the UN Secretary General; the evidence is irrefutable: greenhouse gas emissions from fossil fuel burning and deforestation are choking our planet and putting billions of people at immediate risk. Global heating is affecting every region on Earth, with many of the changes becoming irreversible. The internationally agreed threshold of 1.5 degrees Celsius is perilously close.

NDC Implementation: Good Practices in the Pacific Successfully Concluded



Check <u>here</u> if you require a VISA to travel to Glasgow and apply immediately. For a quicker decision, delegates can use the UK priority services for an additional fee.

<u>Delegates who are exempt</u> from immigration control are also strongly encouraged to apply – free of charge – for an exempt vignette to confirm their exemption status

## PUBLIC CONSULTATION ON THE FUTURE OF RACE TO ZERO

A year after launching the Race to Zero campaign, the High-Level Champions for climate action, Nigel Topping and Gonzalo Muñoz, have launched a 10-week <u>public consultation</u> in which the Champions are calling for <u>written responses</u> from the public, particularly stakeholders from developing countries to strengthen the campaign and ensure it takes into account regional and developing country context. The Champions will then launch next steps for the Race to Zero on the road to COP 26.

The public consultation will be open until 3 September, 18:00 ICT.

#### Funding Opportunities to Get Involved – Adaptation Fund

<u>The 2021 Readiness Grants</u> are open from **20 July-20 September**. This includes <u>Technical Assistance Grants</u> aimed at strengthening the capacity of National Implementing Entities (NIEs) in the areas of



environmental, social and gender risk management as they design, develop and implement concrete adaptation projects and programmes. The grants are also open to countries that need support during the accreditation process, through an NIE that will provide peer support.

#### NDC UPDATES FROM AROUND THE REGION

## 113 New or Updated NDC Submissions before July 31st and Indonesia LT-LEDS



Indonesia, Solomon Island, Malaysia, Samoa, and Sri Lanka submitted their new or updated NDCs in July. In total, 113 Parties submitted new or updated NDCs before the end of July. The UN Climate Change secretariat is preparing the final version of the NDC Synthesis Report to be published in advance of the pre-COP meeting scheduled on 30 September – 2 October 2021. Additionally, Indonesia also submitted their Long-Term Low GHG Emissions Development Strategies (LT-LEDS) in July.
