## A Message from James

*Greetings to all of our partners across Asia and the Pacific region!*

*It is my immense pleasure to be traveling to Bangkok this month and bearing witness to all the great work that is being done in the region. 2017 is very much the year of climate action. The message is loud and clear, in order to achieve the ambitious target of holding emissions below 2°C, we must work together. The responsibility for our planet rests on all of us.*

*In the spirit of this global collaboration, I am proud to announce that the **Marrakech Partnership for Global Climate Action** is in the midst of developing a business plan, in consultation with the High-Level Champions, that will set out specific steps and actions illuminating the path forward for this movement of collaboration in a systematic and sustainable manner. We will keep you posted on how this initiative takes shape in the next few months.*

*The second initiative I want to draw your attention to is **Carbon Pricing**. In Asia, momentum is growing to incorporate carbon pricing approaches in national and sub-national climate policy, with Singapore being the latest country to begin consultations on implementing a carbon tax. Supporting countries that are thinking about market mechanisms to regulate the use of carbon is a priority for UNFCCC and the RCCs. RCC Bangkok has reaffirmed its commitment to aiding this policy strategy and I would urge you all to get in touch with our experts at the Centre if you have any questions about carbon pricing.*

*Finally, it is heartening to see the continued efforts of RCC Bangkok with regard to the Clean Development Mechanism. They are currently working with the DNA of Mongolia to revise the proposed new Grid Emission Factor (GEF) Standardized Baseline (SB) to address the comments received from the Methodologies Panel, which is part of their 2017 plan of activities to help countries and project participants along the CDM cycle.*

*But this is just the start. There are so many ways to get involved. Measure, reduce, and offset your own personal carbon footprint through [Climate Neutral Now](#); encourage your city to declare their commitments on [NAZCA](#); build climate resilience into your business plans; launch a new CDM project. It is you who will imagine and create the future, and it is our role to support your vision and your action.*

*I look forward to being a part of your future.*

**The CDM Executive Board Simplifies Procedures**

After two years of complex discussion and consultation the CDM Board has revised the existing CDM regulations with a view to streamlining and simplifying them for both single project activities and Programme of activities under the CDM, in two distinct sets.

This is great news for our DNAs and project developers as access to as well as the process of the mechanism has been simplified. We do hope you share this within your countries and networks as we work together towards building the robust enabling national and regional ecosystems that will power the fight against climate change.

**Momentum for Change 2017 Awards: Applications Open**

On 30th January, the UNFCCC Secretariat opened the call for applications for the 2017 Momentum for Change Awards to showcase action and ambition as national governments work toward implementing the Paris Agreement and the Sustainable Development Goals.

Selected initiatives, called 'Lighthouse Activities', shine a light on innovative, scalable and replicable examples of what people are doing to address climate change, in the hope of inspiring others to act. The winning activities will be recognized and celebrated during a series of special events in November at the UN Climate Change Conference in Bonn, Germany (COP 23).

## Nationally Determined Contributions (NDCs) Survey Confirms Finance is Urgent Need in Asia

Countries in Asia, Africa, and Latin America and the Caribbean urgently need financial support to green their power sectors and thereby implement their national climate action plans under the [Paris Climate Change Agreement](#). This is a key finding of the report on the NDC survey.

The respondents also emphasized the importance of aligning existing national policy frameworks with INDCs, as well as the key role the private sector will have to play in the coming years with regard to climate financing.

## Singapore to Adopt Carbon Tax from 2019

Some very positive news coming out of Singapore, where the the government has announced their intent to put a price on carbon.

Singapore proposes the application of an upstream tax, for example, on power stations and other large direct emitters, rather than electricity users, with a tax rate between \$10 and \$20.

This is an encouraging signal of the momentum for carbon pricing building in the region.

## State and Trends of Carbon Pricing 2016: World Bank Report

One hundred and one INDCs plan or consider using Carbon Pricing to achieve their stated targets. This report, produced by the World Bank, works towards supporting that climate ambition.

It provides an update on national, subnational, and corporate carbon pricing instruments from around

the world. It also makes a strong case for aligning carbon pricing with the broader policy landscape, providing lessons to policymakers on maximising synergies between climate mitigation and other related policies, while managing potential tensions and tradeoffs. The report provides crucial new modelling that demonstrates the benefits of an international carbon market established under Article 6 of the Paris Agreement; reducing the costs to countries of achieving emission reducing targets thus enabling greater ambition across the world.

Our goal is to bring clean water to 1 million people

### Clean Water through CDM

In the absence of water purifiers, the most natural and easiest home-remedy for purifying water is to boil it.

Humanity has been making water safe for drinking by boiling it for thousands of years. But that is not a

sustainable solution anymore. Boiling requires firewood, and firewood means releasing carbon into our atmosphere. And, when hundreds of thousands of households around the world are doing this, the impact on our environment is substantial.

In Cambodia, the Clean Development Mechanism (CDM) is helping solve the conundrum of water purification through the International Water Purification Programme, which seeks to further the access of families and communities to clean and safe drinking water by promoting low-carbon water purification technologies.

## News from IGES



### **IGES Organises the 8th East Asia High Level Seminar of Sustainable Cities**

**8-9 February, 2017 | Chiang Rai, Thailand**

The Governments of Thailand, Japan, and Cambodia, the ASEAN Working Group on Environmentally Sustainable Cities (AWGESC), and the ASEAN Secretariat hosted around 230 participants, including city officials, national

government representatives, development partners, NGOs, and the private sector, to attend the 8<sup>th</sup> East Asia Summit High-Level Seminar of Sustainable Cities. The IGES Regional Centre has been serving as the Secretariat for the event since 2010.

Over two days, the participants took part in plenaries and smaller thematic sessions focusing their discussion on the theme: "The Role of Cities: Localising the Sustainable Development Goals to Bridge Policy and Implementation". In their discussion, they agreed that cities are well-positioned to localise and drive the implementation of the SDGs in an inclusive and participatory manner. With the expected incorporation of SDGs into national policies, the participants discussed the policy-implementation connection and the need to scale-up pilot initiatives.

## Signing off...

### **The Green Vacuum Cleaner**

We leave you with this eye-popping video from National Geographic and NASA. It tracks the flow of carbon dioxide across the planet over 12 months, starting in January, but the interesting part begins in June, when the Northern Hemisphere has its summer.

As we move into the warmer months and our trees wake up from the winter, trillions upon trillions of leaves are opening, growing, and breathing. Their collective breath literally sucks up the CO2 in the air, cleaning the skies, and storing that carbon in their trunks and branches - the effect is stunning, to say the least.



The video reminds us of the critical role forests play in mitigating climate change, but forests around the world are under threat. According to WWF, some 46-58 thousand square miles of forest are lost each year - equivalent to **48 football fields every minute**.
