COP26 brings attention to the critical decade for climate action

Updates on NDCs and LT-LEDs submissions from the region



After COP26, nations adopted the Glasgow Climate Pact which emphasizes that the 2020s is the critical decade for climate action and support. The Glasgow Climate Pact includes specific decisions on nationally determined contributions (NDCs), long-term low greenhouse gas emission development strategies (LT-LEDs), and the importance of raising and implementing mitigation.

It established a work program to urgently scale up mitigation ambition and implementation and decided to convene an annual high-level ministerial round table on pre-2030 ambition

starting at COP27. It also calls on countries to “revisit and strengthen” the 2030 targets in their NDCs by the end of 2022 to align them with the Paris Agreement’s temperature goals. It also urges all countries that have not yet done so to submit by COP27 long-term strategies towards just transitions to net zero emissions by or around mid-century.

The UNFCCC secretariat is preparing an update of the NDC synthesis report and a synthesis report on LT-LEDs. Together, stronger and well-aligned NDCs and long-term strategies can help ramp up ambition towards the Paris Agreement goals. NDCs, LT-LEDs, and mitigation pledges need to now be urgently translated into real action and transformation on the ground.

To date, 50 LT-LEDs have been submitted to the Secretariat by Article 4, paragraph 19, of the Paris Agreement. Parties who wish to communicate their long-term strategy to the secretariat are invited to send their submissions to LT-LEDS@unfccc.int.

Submission updates from the region:

[Antigua and Barbuda](#), [Belize](#), and [St. Kitts and Nevis](#) submitted updated NDCs to the UNFCCC secretariat before COP26. Of these, Antigua and Barbuda and Belize have also indicated their intention of moving towards net-zero in their updated NDC submissions.

COP26 High-Level event on the needs of developing countries



The [Paris Committee on Capacity Building](#) has developed a toolkit to support the efforts of countries to identify and address their capacity needs and gaps. The toolkit provides an overview of a capacity assessment cycle as well as complementary resources including case studies, tools, best practices, and lessons learned to guide the assessment process that enables countries to identify appropriate steps they can take to strengthen their national capacities to address climate change.

Call for Inputs for the First Global Stocktake




The [Global Stocktake](#) of the Paris Agreement is a process which aims to assess the world's collective progress towards achieving the purpose of the agreement and its long-term goals every five years.

As part of the first Global Stocktake, the chairs of the UNFCCC's Subsidiary Bodies [opened a call](#) last September for Parties and non-Party stakeholders to submit their inputs before the **end of February 2022**. Further details on how to do so can be found [here](#)

New resource and opportunity

A paper on linkages between the Technology Needs Assessment process and the NDC process prepared by the Technology Executive Committee



Stepwise guidance for conducting a Technology Needs Assessment (TNA) can be an important analytical supporting instrument to facilitate NDC design and implementation, especially in developing countries with capacity constraints. The paper analyzes to what extent developing countries who communicated TNAs and NDCs between 2018-2021 used the outputs from TNAs and enhanced understanding of TNA and NDC linkages and how these can be further strengthened.

A case study from Suriname presents a way of effectively engaging stakeholders, as a method to decide on policies and means of implementation. More [here](#)
