Highlights

Virtual Roundtables Kick Off 2021 Regional Climate Weeks

The 2021 editions of the Regional Climate Weeks kicked off in March with virtual regional roundtables designed to set the scene for regional climate action in the run-up to the UN Climate Change Conference COP26 in November.

The roundtables for Latin America and the Caribbean



on 3. and 4. March helped identify priorities and opportunities for the three regions, crucial for the full implementation of the <u>Paris Agreement</u>.

Regional stakeholders framed their discussions on how to recover better from the COVID-19 pandemic and how to scale up and speed up climate action capitalizing on the efforts already ongoing in the regions. Common calls made in all the regions related to:

- The importance of efficiently engaging all actors in climate action, particularly youth and women:
- The imperative of citizen- and community-led efforts to change behaviours, which is essential for more sustainable production and consumption patterns;
- The importance of nature-based solutions and of "bringing Earth back into the equation."

The role of governments in providing clear direction and targets for climate action was also a common message in all the roundtables, with many stakeholders calling for a clear price on carbon and recognition of the value of nature and the costs of its destruction. Participants agreed that climate finance is still a key factor in all regions to implement climate plans and policies. Whilst substantial financial resources are available, they must be channeled to build carbon neutral and resilient societies, especially in developing countries. There was also a shared understanding that financial tools such as green bonds increasingly need to be used to finance future infrastructure.

A report with specific key takeaways and conclusions of the virtual roundtables will be published within shortly.

NDCs submission in time for the initial synthesis report

Argentina, Brazil, Chile, Colombia, Costa Rica, Mexico, Nicaragua, Panama, Peru, Suriname submitted their new or updated NDCs before 31th December 2020. These NDCs have been included in the assessments contained in the *initial NDC synthesis* report. Argentina, Columbia and Panama committed, in their NDCs, to submit Long-Term Strategies with carbon-neutral goal by 2050.

Regarding the final version of the Synthesis report, the secretariat is planning to publish it in advance of the pre-COP meeting, scheduled for 30 September – 2 October 2021. The report will be prepared on the basis of the NDCs recorded in the interim NDC registry as **at 30 July 2021.** To facilitate timely preparation of the report, I strongly urge Parties to submit their new or updated NDCs as soon as possible.

New regional publications and recent events

CDM Executive Board successfully

completes its 109th meeting.



The CDM Executive Board carried out its 109th meeting virtually due to the Covid-19 restrictions. The meeting was chaired by the newly elected Chair, Mr. Olivier Kassi of Belgium and Vice-Chair, Mr. Omar Alcock of Jamaica. The agenda covered multiple topics ranging from the consideration of requests for registration of project activities, clarification of temporary measures to enable the operation of CDM until CMP 16, guidance on technical options to support voluntary cancellations of Certified Emission Reductions, and reporting of the Board's 2020 activities to the Conference of the Parties serving as the Meeting of the Parties (CMP).

It also included the approving of changes to standards for CDM project activities and programme of activities, taking note of updates on policy development, work by the relevant panels and working groups, interactions with the DOE/Accredited Independent Entity Coordination Forum, and providing guidance on the on the ICAP Carbon Offset and Reduction Scheme for International Aviation (CORSIA) of the International Civil Aviation organization (ICAO). A Kickoff of NBF Honduras project: "Climate Finance Tools for Honduran NDC"

On March 1, 2021, a kickoff meeting of the NBF project, "Climate Finance Tools for the National Determined Contribution (NDC) of Honduras", was held virtually by the Presidential Office of Climate Change (Clima Plus), the Secretariat of Energy, Natural Resources, Environment and Mines of Honduras (MiAmbiente), and the RCC Panama of UNFCCC.

This project is part of the Need-Based Finance (NBF) approach launched by the UNFCCC with the objective of facilitating access and mobilization of climate finance for the implementation of priority mitigation and adaptation projects to address the needs identified by developing countries. After the kickoff meeting, discussions on climate finance for prioritized sectors of Honduras were initiated, including the agriculture and livestock, coffee, forestry, and energy sectors.

Latin America interest grows for CTCN technical support

On February 24, 2021, the <u>CTCN</u> Latin America office and RCC Panama organized



an informative webinar on "How to access to technical assistance for climate action in Latin American countries".


This session, presented the link between the CTCN support and the NDCs, shared information on applying for CTCN technical assistance and outlined how

countries can participate in the second call of the <u>Adaptation Fund Climate Innovation Accelerator (AFCIA)</u>. More than 40 participants joined the webinar, including representatives from Ministries of Environment of Brazil, Chile, Colombia, Ecuador, El Salvador, Guatemala, Honduras, Nicaragua, Mexico, Panama, Peru, Uruguay and Paraguay. The session was moderated by the RCC Panama team.

The webinar featured a Q&A focused on how countries that are not eligible for AFCIA can still apply for project and programme funding through the <u>innovation grant funding window</u> of the Adaptation Fund. Note that eligible countries include developing countries that do not have National Implementing Entities. The CTCN LAC team also highlighted that they offer technical assistance up to \$250,000 USD to at least two countries every year, with regional multi-country proposals accepted.

The <u>5th Meeting of the CGE</u> took place virtually on 2-3 March 2021 and elected Ms. Virginia SENA (Uruguay) as the Chair and Ms. Sandra Boitumelo MOTSHWANEDI (South Africa) as the Rapporteur for this year.

Reiterating its commitment to provide technical support and advice to developing countries to continue implementing the existing MRV arrangements and preparations to implement the ETF, the CGE developed its <u>workplan for 2021</u>, including organizing regional training workshops and webinars. The role of agriculture in climate negotiations - webinar with SE-CAC



On March 9, RCC Panama together with the Executive Secretary of the Central American Agricultural Council (CAC) held the webinar "Planning climate action and the role of agriculture in climate negotiations", with the participation of more than 50 attendees.

This space was developed with the purpose of promoting an update and discussion of technical issues, related to the development of the climate agenda and its implication in the context of the agricultural sector of the region. RCC Panama presented the the mechanisms established by the UNFCCC laying the foundation of the current climate action as well as the importance of the implementation of the Nationally Determined Contributions (NDCs).

Additionally, the role that agriculture can play within the Global Climate Agenda was discussed. It was mentioned the forums such as the Koronivia Working Group, which allows opening the dialogue on the importance of agriculture in the fight against change. climate, and how the sector can generate promising opportunities that allow promoting initiatives in a connecting both adaptation and mitigation, as well as the linkage of the sector with the development of National Adaptation Plans (NAP), which must be consistent with the interests and needs of each country.

Transparency of action and support is critical to achieving the objectives of the Convention and the Paris Agreement. Well-functioning institutional arrangement is key to transition to the enhanced transparency framework by 2024. In that context, <u>the toolbox on institutional arrangements</u>, developed by the <u>Consultative Group of Experts (CGE)</u>, is a one-stop shop that offers a technical handbook (available in all UN languages), video interviews and case stories presenting experiences of developing countries in improving and sustaining national MRV process, and a list of relevant technical resources.
