COP26 and other meeting updates

COP26 Postponed



The COP26 UN climate change conference planned to take place in Glasgow in November has been postponed due to COVID-19.

This decision was taken by the COP Bureau of the United Nations Framework Convention on Climate Change, with the UK and its Italian partners.

Dates for a rescheduled conference in 2021, hosted in Glasgow by the UK in partnership with Italy, will be set out in due course following further discussion with parties.

Talking about Climate Action with the Thai Bond Market Association

Sustainability Bond Forum | Bangkok, Thailand | 31 January 2020



RCC Bangkok was invited by the Thai Bond Market Association to speak at the Sustainability Bond Forum to present an overview of COP 26 and countries' commitments towards the SDGs and the Paris Agreement, which have sent strong signals that the world is moving towards resilient, sustainable, low-emission economies and societies.

Participants agreed that a transformation in the finance sector is underway and investing in climate action is an enormous economic and entrepreneurial opportunity.

Common Challenges, Common Needs Climate Finance in the Indian Ocean

NBF-ISIO Validation Workshop | Malé, Maldives | 4-5 March 2020

UN Climate Change's Needs-based Finance (NBF) initiative is working with a group of six



island states in the Indian Ocean that are developing a strategy and implementation framework to mobilize and enhance access to climate finance.

At a recently concluded validation workshop in Malé, Maldives, a technical assessment presenting the gaps, barriers and challenges the island states face in mobilizing and accessing climate finance was presented to

country representatives for their review, comment and agreement.

Asian Transparency Workshop - Implementing the Paris Agreement



IGES and RCC Bangkok recently organized a regional workshop on Transparency and Article 6 for the Implementation of the Paris Agreement.

The workshop saw participation from representatives from 12 countries (10 ASEAN Member States plus Mongolia and Korea), international experts, IPCC technical officers, UN Climate Change colleagues, and IGES researchers.

Countries shared their experiences in preparing National Communications (NCs) and Biennial Update Reports (BURs) as well as the usefulness of NCs and BURs in formulating domestic climate actions. Additionally, countries exchanged their views on Article 6 negotiations and the potential role of market mechanisms in their NDCs. The workshop also provided a full-day training on the use of 2006 IPCC Guidelines for national GHG inventories.

This workshop received financial support from the Ministry of the Environment, Japan. This is the third workshop IGES and RCC Bangkok have organized on the topic since 2018.

In light of the COVID-19 pandemic, the 17th Meeting of the Adaptation Committee (AC 17), took place virtually on the originally scheduled dates, 24-27 March 2020. All 16 AC members, along with 29 observers, joined the meeting to advance the Committee's work in areas such as

recognizing the efforts of developing countries to address hazards, data for adaptation, and assessing progress towards the global goal on adaptation.

37th Meeting of the LEG | Antananarivo, Madagascar | 6-8 February, 2020

At the meeting, the Group developed its work programme for 2020. The meeting included discussions with representatives of the Green Climate Fund, relevant organizations, regional centres and networks on ongoing collaboration to support the least developed countries on adaptation and the implementation of the least developed countries work programme. Consultative Group of Experts formulates its Vision, Mission and Strategic objectives



The Consultative Group of Experts (CGE), an expert group under the Convention and the Paris Agreement mandated to provide technical support and advice to developing countries on MRV and transparency, met in Bonn from 18 to 19 February 2020.

With a view to ensuring that its annual work plan aligns with its mandate and objectives, and responds to the evolution of the existing measurement, reporting and verification (MRV) arrangements under the Convention and the enhanced transparency framework (ETF) under the Paris Agreement as well as needs identified by

developing country Parties in the lead up to 2026, the expert group formulated a Vision, Mission statement and Strategic objectives. The CGE's vision is to comprehensively achieve its mandate of assisting developing country Parties improve their capacities to implement the existing MRV arrangements under the Convention and the ETF under the Paris Agreement in a timely and sustainable manner.

The campaign is based around a mobile game that educates people about climate policy and provides a platform for them to vote on the solutions they want to see happen. The votes will then be compiled and analyzed by researchers at the University of Oxford before being delivered to government leaders and climate policymakers.
