
## Virtual Global Forum 2020 Achievements and Progress of Work RCC Dubai

## **Mitigation**

- Offered support and assisting on a regular basis Designated National Authorities (DNAs) in the region on Standardized Baselines development – Actively engaged with DNAs of UAE, Tunisia, Sudan, Morocco, Jordan and Egypt
- Campaigns launched on an on-going basis to connect CDM project developers with buyers of CERs; to 10 projects which submitted Prior Consideration Forms for CDM projects, and to 19 PAs and PoAs sharing information for listing Certified Emission Reductions (CERs) from their CDM project on the UN Carbon Offset Platform
- Supporting the **Dubai Carbon Centre** to pilot the digitized methodologies platform of the secretariat
- Initiated a Virtual Workshop Series for Designated National Authorities (DNAs) to build capacity based on their stated needs in collaboration with RCC Bangkok; two Virtual Workshops held, with three more to follow.



## Adaptation

Supporting the Lima Adaptation Knowledge Initiative (LAKI) in the region through the Implementing Actions to Close Knowledge Gaps in MENA project

This project supports in **identifying** and **engaging** with relevant institutions and experts in closing identified priority knowledge gaps in adaptation and in developing and disseminating knowledge in **developing** and **disseminating** knowledge products for the intended users.

- United Nations Economic and Social Commission for Western Asia (UN ESCWA) and UN Environment Programme (UNEP) have joined the project as implementing partners
- Undertaken extensive **mapping and stock take exercise** to identify relevant institutions, experts and initiatives related to adaptation in the region
- Conducted virtual engagements by project partners with 12 organizations and 47 initiatives in the region to ascertain current status of identified knowledge gaps
- Initiated **analysis** of data collected from virtual engagements
- An Expert Workshop will be organized to develop a roadmap and to assign action items in support of the closing of identified and prioritized knowledge gaps in the region



### Arab States Climate Finance Mobilization and Access Strategy

This project comprises of **assessing** climate finance barriers among Arab countries and **prioritizing** climate finance and investment needs for the region.

- League of Arab States (LAS) secretariat and UN ESCWA joined the project as implementing partners
- Organized an Inception Workshop to kick-off the project in November 2019 in Cairo, Egypt
- Organized special sessions on climate finance at five High-level WGEO Regional Ministerial Conferences around the world (June - July 2019) and a global event at the World Green Economy Summit in October 2019
- Produced a <u>Synthesis Report (Knowledge Product)</u> on the outcomes from the regional and global sessions
- Organized <u>High-level Forum on Climate Finance Strategies for NDC implementation at</u> COP25
- Briefing to Arab negotiators during SB50 and COP25
- Organized <u>Technical Workshop on Climate Finance for Finance Experts in the Arab</u>
   <u>region from the Ministries of Finance, February 2020 in Cairo, Egypt</u>
- Technical assessment on climate finance needs and priorities developed



## **Needs-based Climate Finance**

# Climate Finance Mobilization and Access Strategy for South and Southwest Asia (Afghanistan, Iran and Pakistan)

This project comprises of **assessing** climate finance barriers among project countries and **prioritizing** climate finance and investment needs for the region.

- United Nations Economic and Social Commission for Asia and the Pacific (UN ESCAP) joined the project as implementing partners
- Engagement with the participating countries ongoing discussions underway with nominated country focal points on finalizing a mutually agreed project plan.
- Mapping of climate finance institutions in Afghanistan, Iran and Pakistan as preparatory work for the project



## **Facilitating Support for Nationally Determined Contributions (NDCs)**

- Prepared and disseminated a survey on the status of new/updated Nationally
   Determined Contributions (NDCs) to 30 country focal points covered by RCC Dubai The survey was created with inputs from several experts and regional organizations
- Supporting the organization of a three-day Virtual workshop for countries in MENA to enhance understanding on the process and provisions for NDCs
- Engaging with the regional Issue-based Coalition (IBC) on Food Security, Climate Action and Environment to coordinate activities facilitating support for of NDC updates / implementation.
- Providing support to the Consultative Group of Experts (CGE) virtual training on the existing MRV arrangements and the enhanced transparency framework to increase regional capacity on the ETF.

- Engaged with 30 countries in MENA and South Asia to increase coverage of Action for Climate Empowerment (ACE) by facilitating and supporting these countries in nominating ACE focal points

- Enhancing coverage of <u>Climate Neutral Now</u> in the region
