1. Opening of the meeting.

- 1. The 20^{th} meeting of the Standing Committee on Finance (SCF) was opened at 9 a.m. on Thursday, 21 March 2019.
- 2. New members to the SCF were welcomed to the SCF. The SCF also observed a moment of silence followed by a video for a former longstanding member of the SCF, Ms. Bernarditas Muller.

2. Election of officers.

3. The SCF elected Mr. Ayman Shasly and Mr. Ismo Ulvila as Co-Chairs of the SCF for 2019.

3. Organizational matters.

(a) Adoption of the agenda

4. The SCF adopted the agenda contained in document SCF/2019/20/2 as proposed.¹

(b) Organization of the work of the meeting

Proceedings

- 5. The SCF took note of the proposed tentative schedule as well as the order of work for the meeting.
- 6. Members discussed their involvement in the various areas of work for 2019 and suggested to expand their outreach at various related events throughout the year.

Outcomes

- 7. SCF members agreed to the proposed priority areas of work that were presented to members by the Co-Chairs.
- 8. SCF members also agreed to enhance their outreach on SCF matters by indicating their representation at related events in 2019.

4. 2019 workplan of the Standing Committee on Finance, including COP mandates:

Proceedings

- 9. The SCF took note of document SCF/2019/20/3. The agenda item was introduced in the first plenary and was further discussed during a second plenary session.
- 10. A presentation was made by the secretariat on a possible webinar on gender that could be organized for SCF members this year.

Outcomes

- 11. SCF members considered the key activities and additional mandates emanating from the COP and CMA and agreed to a revised workplan (see Annex I), as well as an updated list of SCF mandated activities.² SCF members underlined the importance of outreach to promote the outcomes of its work in 2018 and to support work to be undertaken in 2019–2020. The SCF agreed to develop a strategic outreach plan to be circulated intersessionally to the SCF.
- 12. Members also considered the possibility to organize a webinar based on the presentation delivered by the secretariat. It was clarified that the webinar would be part of its outreach activities, it would address activity C.2 of decision 3/CP.23, annex, table 3, and also be part of the dialogue mandated by activity D.1 of decision 3/CP.23, annex, table 4. The dialogue would also be considered by the gender related activities of the 2019 Forum and also in the preparation of the 2020 Biennial Assessment and Overview of Climate Finance Flows.
- 13. SCF members agreed to hold an informal meeting during the June sessions to take stock of activities mid-way through the year.

Next steps

- 14. Co-Chairs, with the support of the secretariat, to develop and circulate a strategic plan for outreach in 2019-2020 for consideration by SCF members intersessionally.
- 15. Co-Chairs, with the support of the secretariat, to facilitate arrangements for a webinar to be organized intersessionally with SCF members and selected experts on gender.
- 16. The secretariat, under the guidance of the Co-Chairs, to make the necessary arrangements for an informal meeting during the June sessions.
- 4a. Preparatory work on the 2020 Biennial Assessment and Overview of Climate Finance Flows, including, information relevant to Article 2, paragraph 1 (c) of the Paris Agreement;

Proceedings

17. The SCF took note of document SCF/2019/20/4. This agenda item was introduced in one plenary session and discussed further in the context of one breakout group session facilitated by Ms. Vicky Noens and Mr. Seyni Nafo, who were appointed as the co-facilitators for this agenda item. The outcomes of the discussions were presented to the SCF for its consideration.³

Outcomes

- 18. The SCF agreed to follow the approach taken in the 2018 Biennial Assessment and Overview of Climate Finance Flows (BA);
- 19. The SCF deliberated on the treatment of the mandates arising from the COP24 outcomes, as reflected in the preliminary draft outline of the 2020 BA, as contained in annex II. The SCF agreed to continue work on this matter intersessionally.

Next steps

- 20. The co-facilitators, with the support of the secretariat, will develop an advanced draft of the outline of the 2020 BA for consideration and finalization by SCF21;
- 21. The secretariat, under the guidance of the co-facilitators, will develop a workplan, including outreach activities for the 2020 BA intersessionally;
- 22. The co-facilitators, with the support of the secretariat, initiate technical work and outreach activities early on, including exploring the possibility of organizing an intersessional technical experts workshop on 2020 BA in 2019.
- 4b. Preparatory work on the first report on the determination of the needs of developing countries related to the implementation of the Convention and the Paris Agreement;

Proceedings

23. The SCF took note of document SCF/2019/20/5. This agenda item was introduced in one plenary session and discussed further in the context of two breakout group sessions facilitated by Mr. Zaheer Fakir and Mr. Mattias Frumerie, who were appointed as co-facilitators for this agenda item. The outcomes of the discussions were presented to the SCF for its consideration.⁴

Outcomes

24. The SCF agreed to initiate preparatory work on the first report on the determination of the needs of developing country Parties at SCF20. The SCF shared preliminary views on the objective, approach, activities and indicative timelines of the first report presented in a note by the co-facilitators (see annex III).

Next steps

- 25. The co-facilitators, with the support of the secretariat, will intersessionally:
- (a) Develop the draft outline of the report for consideration by the SCF with a view to finalize it by SCF 21;
- (b) Develop a workplan, including outreach activities for consideration and finalization by SCF 21;
- (c) Initiate technical work on information gathering for the mapping and analysis of available information on the needs of developing country Parties, including:
 - (i) Data collection from different reports and databases;

- (ii) Undertaking data gaps and analysis;
- (iii) Obtaining information on various methodologies being used to determine developing country Parties' needs;
- (d) Reach out to developing country Parties and relevant organizations and stakeholders that have undertaken work on methodological issues;
 - (e) Issue a call for on views and suggestions for further sources;
- (f) Note technical discussions of the workshop on methodologies and processes for determining and assessing the needs of developing country Parties on 10–11 July 2019 in Manila, Philippines.
- 26. The secretariat, under the guidance of the co-facilitators, prepare a background paper on sources of information and the methodologies and approaches prior SCF21. The background paper would build on information on sources of information contained in annex to document SCF/2019/20/5 and draw from outcomes of the work referred to in paragraph 25(c) and (d) above and the workshop referred to in paragraph 25 (f) above.
- 27. The secretariat, under the guidance of the co-facilitators, organize events during the 50th sessions of the subsidiary bodies (June, 2019) and 25th session of the Conference of the Parties (December, 2019) as part of the outreach plan.

4c. Draft guidance to the Operating Entities of the Financial Mechanism;

Proceedings

28. The SCF took note of document SCF/2019/20/6. This agenda item was introduced in one plenary session and discussed further in the context of one breakout group sessions co-facilitated by Mr. Toru Sugio and Mr. Paul Oquist-Kelley. The outcomes of the discussions were presented to the SCF by the co-facilitators at the closing plenary session for its consideration.

Outcomes

- 29. Relating to the preparation of the draft guidance for the consideration of the COP and the CMA, the SCF agreed that:
- (a) A common set of draft guidance should be prepared for consideration *both* by the COP and the CMA;
- (b) Should there be draft guidance that would need to be specifically considered by the CMA, this draft guidance should be clearly identified through a distinct heading within the common set of draft guidance.
- 30. On ways to further improve the quality of the draft guidance to the operating entities, the SCF agreed that:
 - (a) The two options outlined in the background note⁵ should be implemented;
- (b) The SCF should continue to utilize the database of previous guidance to the operating entities, as well as the criteria it has established to technically assess the inputs received.

Next steps

- 31. The SCF agreed to prepare draft guidance to the operating entities at SCF 21.
- 32. The SCF requested the secretariat to:
- (a) Adjust the template for inputs to indicate whether the suggested guidance is for the consideration by the COP and/or the CMA, and make the template available on the SCF website;

- (b) Communicate the outcomes of the SCF's discussions on the draft guidance to the AC and the TEC and invite them to provide inputs to the draft guidance by using the adjusted template;
- (c) Post on the SCF website a timeline of preparation of the draft guidance to the operating entities, including the deadlines for inputs.

4d. Measurement, reporting and verification of support beyond the Biennial Assessment and Overview of Climate Finance Flows;

Proceedings

33. This agenda item was introduced in one plenary session by Mr. Randy Caruso and Mr. Nafo, who were appointed as the co-facilitators for this agenda item.

Outcomes

34. The SCF agreed that the Committee, in accordance with the extended 2016–2017 workplan on MRV of support beyond the BA, will explore relevant issues in the context of the BA in 2019.

Next steps

35. In 2019, the SCF's work on MRV of support beyond the BA will be pursued in the context of the 2020 BA.

5. 2019 Forum of the Standing Committee on Finance

Proceedings

36. The SCF took note of document SCF/2019/20/7. This agenda item was introduced in one plenary session and discussed further in the context of two breakout group sessions co-facilitated by Mr. Mo Nasr and Mr. Pieter Terpstra. The outcomes of the discussions were presented to the SCF by the co-facilitators at the closing plenary session for its consideration.

Outcomes

- 37. The SCF agreed:
- (a) On the provisional programme of the 2019 Forum, as contained in annex IV.
- (b) To decide on the dates and venue for the 2019 Forum inter-sessionally, based on a shortlist of possible candidates as listed in the table below, taking into account:
 - (i) Possible substantive linkages with each option and;
 - (ii) Budget and legal implications.

38. The SCF also agreed to engage with the PCCB and its working group on cities and seek their expert views on the capacity-building related components of the Forum.

Next steps

- 39. The SCF requested the secretariat to collect information from the possible partner organizations listed in the table above on any logistical and financial support that the organizations may offer to the SCF. Based on the information collected and taking into account any legal implications in signing the host country agreement, the SCF will make the decision on the dates and the venue of the Forum inter-sessionally.
- 40. Based on the provisional programme, the co-facilitators will start to design the details of each session of the Forum, which may include the flow of each session, possible guiding questions and relevant literature that may be shared with the Forum participants, and identify possible resource persons and case studies. The co-facilitators will also start to engage with the PCCB and its working group on cities to solicit their expert inputs on the Forum.

6. Enhancing stakeholder engagement.

Proceedings

41. The Co-Chairs introduced the ongoing pilot initiative started at SCF 19, including a webinar to brief observer climate finance focal points in advance of SCF 20, as well as virtual participation at SCF 20. SCF agreed to defer consideration of this agenda item until its next meeting (SCF 21).

Next steps

42. The Co-Chairs, with the support of the secretariat, to include this item on the provisional agenda for SCF 21.

7. Linkages with the Subsidiary Body for Implementation and the thematic bodies of the Convention.

Proceedings

43. The agenda item was introduced in the first plenary and the Co-Chairs invited the focal points for the thematic bodies to report back to the SCF on the meetings that they had attended and any other intersessional work.

Outcomes

- 44. Mr. Frumerie reported on his presentation at the Koronivia workshop at the Katowice conference on issues related to agriculture, outlining in the work of the SCF and the related products produced by the Committee. He highlighted its usefulness, including its relation to the outreach activities of the SCF.
- 45. Mr. Caruso reported on his participation at the 8th meeting of the Executive Committee on the Warsaw International Mechanism for Loss and Damage (ExCom), and the draft input prepared by Mr. Oquist-Kelley and himself as an input to the technical paper being prepared for SB 50 on elaborating the sources of financial support, as provided through the Financial Mechanism for addressing loss and damage, finance

available for addressing loss and damage outside the Financial Mechanism, as well as modalities for accessing such support and finance. The SCF noted the proposal that Mr. Oquist-Kelley attend the upcoming 9th meeting of the ExCom. SCF members deliberated on the draft input and agreed to forward it to the ExCom for further consideration towards the technical paper being prepared by the secretariat.

46. The Co-Chairs reported on their discussion with the Adaptation Committee Co-Chairs that took place in the margins of SCF 20. SCF members noted that discussions on adequacy and effectiveness had not yet been finalized, and that future synergies and collaboration should be explored. SCF members also noted that further collaboration should be addressed as part of existing products, for example related to the development of methodologies, work related to the National Adaptation Plans, and the report on the first report on the determination of the needs of developing countries related to the implementation of the Convention and the Paris Agreement. SCF Co-Chairs mentioned several areas where operational action would be taken forward, including exchange of workplans between the two Committees, exchange of timelines for future relevant work, a response to correspondence received from the Adaptation Committee Co-Chairs, and continued engagement by the respective focal points for each of the Committees.

Next steps

47. SCF Co-Chairs and SCF focal points on adaptation, with the support of the secretariat, to undertake activities with the Adaptation Committee, including the exchange of workplans between the two Committees, exchange of timelines for future relevant work, a response to correspondence received from the Adaptation Committee Co-Chairs, and continued engagement by the respective focal points for each of the Committees.

8. Report of the twentieth meeting of the Standing Committee on Finance.

Next steps

- 48. The Co-Chairs, with the support of the secretariat, will prepare the draft report for consideration by SCF members on a no-objections basis.
- 49. The list of participants for SCF 20 will be made available on the UNFCCC website.

9. Other matters.

Proceedings and outcomes

50. The SCF explored various options for possible meeting dates for SCF 21. The SCF agreed to confirm the dates for SCF 21 intersessionally.

Next steps

- 51. The secretariat will circulate possible meeting dates to the SCF for intersessional decision making by 31 July 2019.
- 52. The Co-Chairs, with the support of the secretariat, will circulate the SCF 21 provisional agenda to SCF members at last six weeks prior to SCF 21.
- 53. The Co-Chairs, with the support of the secretariat, will circulate the SCF 21 annotations to the provisional agenda at least four weeks prior to SCF 21.

10. Closure of the meeting.

54. The 20th meeting of the SCF closed at 2:15 p.m. on Friday, 22 March 2019.
