# Report on the meeting

### 1. Opening of the meeting

- 1. Mr. Joseph Aitaro, chairperson of the enforcement branch, declared the meeting open at 14:30 hrs. He welcomed the members and alternate members of the branch who were present at the meeting. The chairperson also welcomed Ms. Hafida Lahiouel, the Principal Legal Adviser of the secretariat and the Director of the Legal Affairs Programme of the UNFCCC.
- 2. At the request of the chairperson, the secretariat provided information on participation and quorum, as well as key administrative, logistical, and housekeeping arrangements. The secretariat confirmed that there was a quorum for the meeting, that the meeting was recorded and broadcasted on the UNFCCC website, and that an audio recording was being made of the entire meeting.

### 2. Adoption of the agenda

3. The branch adopted the provisional agenda (CC/EB/32/2018/1).

### 3. Organization of work

- 4. The branch decided to organize its consideration of the items in the following manner:
  - (a) First, to consider the questions of implementation with respect to Monaco and to elaborate and adopt a decision under section X, paragraph 1(d), of the "Procedures and mechanisms relating to compliance under the Kyoto Protocol" with respect to Monaco;
  - (b) Second, to discuss other matters.

# 4. Consideration of the questions of implementation with respect to Monaco

- 5. At the request of the chairperson, the secretariat provided a summary of the proceedings since the adoption by the branch of a preliminary finding of non-compliance with respect to Monaco (CC-2018-1-2/Monaco/EB) on 31 May 2018.
- 6. Also at the request of the chairperson, the delegation of Monaco informed the meeting that, in accordance with section VIII, paragraph 2, the following designated representatives of Monaco participated in the meeting through electronic means:
  - (a) Ms. Valérie Davenet, Director, Department of the Environment;
  - (b) Mr. Jérémie Carles, Head of Division, Department of Environment.
- 7. As part of the consideration by the branch of the question of implementation with respect to Monaco, the branch provided Monaco with the opportunity to make a presentation. In its presentation, Monaco outlined measures planned to remedy the issues raised in the question of implementation, including enhancing the capacity of the inventory team, improving the inventory database, and taking appropriate legislative measures to improve the availability of data.
- 8. After the elaboration of a final decision during a meeting held in private in accordance with rule 9, paragraph 2, the branch adopted the decision at 04:50 hrs Greenwich Mean Time on 30 August 2018.

### 5. Other matters

- 9. The branch agreed to meet in conjunction with the meeting of the plenary in 2019, unless the branch receives any information the consideration of which would require a meeting earlier in the year. It requested the chairperson and vice-chairperson to finalize the meeting schedule in consultation with the members and alternate members, and the secretariat.
- 10. No other matters were raised.
