Based on the request of the CMA in its decision 3/CMA.3 and decision 7/CMA.4 and taking into account inputs received from stakeholders, the Supervisory Body approved the recommendation to the CMA related to “Requirements for the development and assessment of Article 6.4 mechanism methodologies”, as contained in annex 1 to this meeting report.

Based on the request of the CMA in its decision 3/CMA.3 and decision 7/CMA.4 and taking into account views of Parties and observers as well as inputs from stakeholders, the Supervisory Body approved the recommendation to the CMA related to “Activities involving removals under the Article 6.4 mechanism”, as contained in annex 2 to this meeting report.

9. The Supervisory Body expressed its appreciation to the outgoing Chair, Ms. Olga Gassanzade, and Vice-Chair, Mr. El Hadji Mbaye Diagne, for their dedication in chairing the meetings this year. The Supervisory Body also thanked all outgoing members and alternate members.
