Draft conclusions proposed by the Chair

OPTION 1.

1. The Subsidiary Body for Implementation considered the note by the secretariat on the status of submission and review of national communications and biennial reports¹ and took note of the information therein.

OPTION 2.

1. The Subsidiary Body for Implementation considered the note by the secretariat on the status of submission and review of national communications and biennial reports² and noted with concern the delays in submitting fifth biennial reports and eighth national communications on the part of some Parties included in Annex I to the Convention.³ It noted that, since the publication of the note, submissions from one additional Party have been received.

3b.

Draft conclusions proposed by the Chair

1. The Subsidiary Body for Implementation (SBI) considered the compilation and synthesis prepared by the secretariat of fifth biennial reports of Parties included in Annex I to the Convention (Annex I Parties)⁴ and acknowledged that the report provides valuable information to Parties, including lessons learned relevant to implementing the Paris Agreement, and the general public.

OPTION 1

2. The SBI took note of the information provided in the report referred to in paragraph 1 above.

OPTION 2

- 1. The SBI noted that, according to the report referred to in paragraph 1 above, nearly all Annex I Parties met their quantified economy-wide emission reduction targets under the Convention for 2020.
- 2. The SBI also noted that, while the total aggregate greenhouse gas emissions of Annex I Parties decreased by 17.3 per cent without land use, land-use change and forestry in 1990–

2021, emissions without land use, land-use change and forestry of Annex I Parties that do not have economies in transition fell by 7.4 per cent in the same period.⁵

- 4. The SBI further noted that the projected level of emissions reported by Annex I Parties in their fifth biennial reports under the 'with measures' scenario does not show any significant decrease between 2020 and 20306; since those reports were submitted, however, some Parties have implemented new policies and measures aimed at meeting targets for beyond 2020 and achieving transformation across sectors that are major contributors to GHG emissions.
- 5. The SBI noted that total climate finance (annual average on a comparable basis) provided by Annex I Parties to developing countries increased continuously between 2011 and 2020, albeit at a slower rate in the two most recent bienniums (2017–2018) and (2019–2020), and that the capacity-building activities supported by Annex I Parties for developing countries has increased in 2019–2020 compared to 2017–2018.

3c. Draft conclusions proposed by the Chair

1. The Subsidiary Body for Implementation considered the report prepared by the secretariat on national greenhouse gas inventory data for 1990–2021⁷ and took note of the information therein.
