They have international rights under UNDRIP (2007) to engage freely in economic activities (Article 20), to pursue economic development (Articles 21 & 23), and to exercise rights to own, use, develop and control their lands, territories and resources (Article 26). This establishes a right of Indigenous nations to trade directly, or abstain from trading under Article 6 of the Paris Agreement, as the rightful owners of mitigation outcomes that occur on their territories.
