# How discussions on NMA should be framed?

## Non-market approaches

The NMA workprogramme constitutes a unique opportunity to support the ambition of national climate goals in line with the objective of not exceeding the 1.5 C threshold.

The work programme must be framed by the urgent need of **achieving net zero and the long term resilience**, beyond the traditional approach that deals separately with adaptation and mitigation of climate change.

## *How can facilitating these non-market approaches in the work programme assist Parties in implementing their NDCs?*

- ***Open conversation about innovative initiatives that accelerate emission reductions and contribute to long-term resilience should be given, in light of the latest science.***
- ***Strengthen synergies and visualize existing initiatives and actions that can be disseminated.***
  - *For example:*
    - ❖ *Estimation of co-benefits of implementing a climate-resilient strategy*
    - ❖ *Enabling policies, measures and actions : Regulatory and policy frameworks aimed at enabling the relevant sectoral transformations towards decarbonization including incentives.*

# How can including the proposed potential additional focus areas and their related NMAs enhance the work programme?

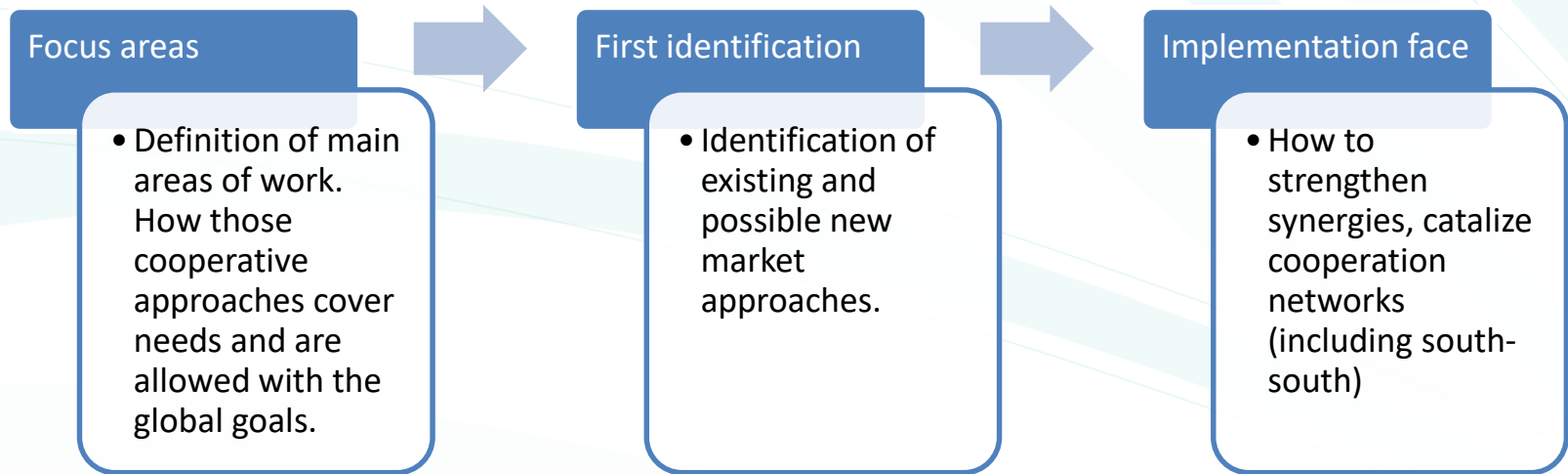
Broaden the action pathway and help us identify new and innovative opportunities that effectively respond to national circumstances.

- ❖ *Estimation of co-benefits of implementing a climate-resilient strategy*
- ❖ Just transition
- ❖ Climate change and circular economy
- ❖ Non-market economic and financial instruments

## What specific functions of the UNFCCC web-based platform can support Parties to identify, develop, and implement NMAs?

- ❖ Share information on **existing initiatives and possible new innovative NMA**.
- ❖ Collect information on success cases, best practices and lessons learned during the implementation of NMA.
- ❖ Serve as place to catalyze networks on specific NMA.
- ❖ The platform should be linked to or receive information from other platforms such as the Global Climate Action and the knowledge portal of the NDC partnership.
- ❖ Finally, the platform could serve as repository of Countries' needs that have to be covered in order to achieve NDCs, LTS and global goals. Likewise, information on cooperation and financing initiatives offered by developed countries could also be included.
- ❖ Other platforms/initiatives outside the Convention do something similar but:
  - ❖ Do not include all Countries under the Paris Agreement.
  - ❖ Most of information about needs and related initiatives that could cover those needs are not in a web-based platform.

- What time period should the work programme schedule cover and what are the activities and expected outcomes for each activity in the work programme schedule?
