### **Twenty-Fourth Meeting of the Standing Committee on Finance 19–20 May 2021**

#### **Technical Stakeholders Dialogue on the preparation of the Biennial Assessment and Overview of Climate Finance Flows and the Report on the determination of the needs of developing country Parties 18 May 2021**

Pursuant to decision 2/CP.17, section IV, I am pleased to notify constituencies of admitted non-governmental organizations (NGOs) that the twenty-fourth meeting of the Standing Committee on Finance will take place from 19 to 20 May 2021. A technical stakeholders dialogue will be held on 18 May 2021, prior to the start of the official meeting.

The dialogue will serve as a vital platform for interested stakeholders to contribute towards the ongoing mandated work on the fourth (2020) Biennial Assessment and Overview of Climate Finance Flows and the first report on the determination of the needs of developing country Parties related to implementing the Convention and the Paris Agreement. Owing to travel restrictions due to the COVID-19 pandemic, the meetings will be held virtually, from 12 p.m. to 3 p.m. Central European Summer Time each day.

The meeting will be open to admitted observer organizations. Representatives of admitted NGOs nominated by constituency focal points must register for the meeting using the observer registration form for NGOs, which has been sent to constituency focal points. Kindly note that only **two representatives per constituency** will be permitted to participate in the official meeting and the technical stakeholders dialogue, and all other interested observers may follow the meeting proceedings via live broadcast.
