Secretariat responses to requests from Parties for information and clarification received at the budget contact group meeting on 7 June 2023 and in writing after the meeting¹

1. Request: Please clarify whether GST-related activities are embedded in the core budget even under ZNG scenario despite not being category 1?

> Response:

There is a small portion of support for GST-related activities in the core budget under the ZNG scenario (category 2). Support would be provided by existing staff resources who are also working on research and systematic observation, cooperation with the IPCC and strengthened ocean-based action.

2. Request: Clarify why some elements that should be classified as category 2 and 3 (for example facilitation of strategic direction), are costed as core.

> Response:

The provision of strategic direction and planning in order to effectively implement party mandates is an essential and long-term requirement for any effective institution, including the UNFCCC secretariat. The budget methodology endorsed by the COP requires the inclusion of essential and long-term activities in the core budget.

3. Request: Present core budget with the same elements and level of details as other budgets.

> Response:

The core budget is presented at the same or greater level of details as compared to other budgets. Activities in the core budget should be long-term in nature (category 1 and category 2) and are therefore presented in a programme format. Projects are presented under the Trust Fund for Supplementary Activities and not under other funding sources. Supplementary activities are grouped into projects and overarching objectives for fundraising purposes.

4. Request: Could NDC formulation be included in core? NDC formulation is currently not included. ZRG is not sufficient to address all issues, we believe some activities should be moved to core as they are mandated.

> Response:

Certain activities currently in supplementary budget could be funded by Core Budget. With the Parties' support, the shifting of some mandated activities under Category 3 and 4 and even Category 2, which could not be included in the core budget such as EFT, could be achieved enabling the Secretariat to plan activities based on reliable and predictable core budget. However, the ZRG scenario as currently prepared only includes the statutory costs increases and inflation.

5. Request: The ETF is fully under supplementary which provokes a crisis. This function should be entirely funded by core. Please provide information on other contributions to ETF (other than from the US).

> Response:

The implementation of the ETF is covered by both core and supplementary budget in 2022-2023. However, the development of the ETF tools is fully covered by supplementary funding as the 2022-23 budget has already been approved when Parties agreed on the ETF tables/formats at Glasgow COP. Consequently, there are <u>no</u> core funds for ETF tools in the current budget. Preparation of ETF tools started after Glasgow COP, based on the expected funding to be provided by developed Parties that pledged their contributions at the time of adoption of the tables/formats. By July we urgently need EUR 2 million to continue the project and deliver the test versions in August. Then, we need EUR 3 million in September to deliver the second release of the test versions in mid-November (before COP) and then EUR 3.5 million in Jan. 2024 to be able to deliver the final versions of the tools in June 2024. The main contributors to the ETF tools project are: before Jan 2022 - Japan, Russian Federation, Norway, Germany (these funds were used in the early phases of the project during 2022); since Jan 2022 - Japan, Norway, Germany, USA, Switzerland.

6. Request: Can you indicate the "total net assets", in other words, how much budget is left over the past five years for the Core budget and Supplementary fund?

> Response:

The net assets for all trust funds managed by UNFCCC Secretariat are reflected in the unaudited annual financial statements (AFS) posted on the UNFCCC website. Please find the AFS on the UNFCCC website at: https://unfccc.int/documents/627779.

7. Request: Please indicate the total budget for each category, in particular Category 1. We only know the total amount of Category 1 and Category 2

> Response:

Please find the category breakdown for the total integrated budget against the various categories. The below does not include the 7% adjustment for future inflation.

> Response:

Please find the rationale and mandate for the projects outlined.

Project 101-006 (1) - EUR 1,939,726:

For the 2024/25 biennium this project updates project 101-006 from the current biennium and incorporates also project 400-006-3 from the current biennium in order to streamline and consolidate the number of projects. The implementation rate for both of these projects has increased in 2023 compared to 2022 based on the completion of recruitments for relevant positions and therefore a higher implementation rate is expected for 2024/25

Project 102-006 - EUR 2,053,538:

Based on the mandates for engagement in COP27 decisions some aspects of the work in the current biennium have been reclassified from objective 4 to objective 1b and as a result some activities and related budgets reassigned from project 400-006-2 to project 1002-006. This implementation rates of projects 1002-006 and 4000-006-2 are greater in 2023 than in 2022 and this increase in implementation rate is expected to continue into 2024.

Project 300-006 - EUR 5,725,046:

Implementation rates for 2023 are ahead of the rate in 2022. The increased budget estimate relates to necessary upgrades and operational processes for GCAP/NAZCA in response to COP27 and CMA 4 decisions.

Project 400-001 - EUR 2,371,463:

The increase in budget from 2022/2023 to 2024/2025 is approximately EUR 200k. The main reason for the low budget implementation in the current biennium is the lack of funding. This is an interagency initiative that expands and contracts based on support availability. As it is a Category 4 activity in our budget, it relies totally on non-governmental contributions.

Project 400-006 (1) - EUR 3,336,129:

The Communications subdivision has multiple cross-cutting objectives and communicates authoritative, relevant and timely information to Parties, non-Party stakeholders and the public regarding the UNFCCC process and action on climate change. Given the increasing number of mandates overall, the tasks for the Communications subdivision to communicate about progress in delivering these programmes and activities has risen in tandem. The secretariat has a mandate to communicate authoritative, relevant and timely information to Parties, non-Party stakeholders and the public regarding the UNFCCC process and action on climate change. Specific mandates emanating from the UNFCCC process, including those related to the constituted bodies, request that progress updates and decisions be made publicly available. These mandates are implemented by the Communications subdivision.

Project 400-007 - EUR 744,631:

- Mandate: Article 6 of the Convention and Articles 11 and 12 of the Paris Agreement on education, training, public awareness and capacity building.
- The objectives of the project have been expanded from the previous one, as well as the corresponding activities to meet the overarching goal of enhancing the legal knowledge of the UNFCCC process to ensure a meaningful engagement of young negotiators, presiding officers, observer organizations, policy makers and legislators. Activities range from developing two e-learning courses on priority climate matters to conducting capacity-building events (4 training sessions and 2 thematic workshops) to enhance the capacity of negotiators to take effective climate action and implement international climate commitments at national level. The project also encompasses enhancing the data and knowledge management practice in the Legal Affairs Division to support the development of a trusted and up-to-date repository of legal advice. Staff needed to implement and coordinate this project is also included.

Project 500-009 - EUR 1,695,000:

- Mandate: Article 12 of the Convention, Articles 5–8, 12 and 17 of the Kyoto Protocol and Article 17 of the Paris Agreement.
- The secretariat has initiated the process of upgrading the ICT infrastructure in line with keeping the secretariat's infrastructure well-managed, up-to-date and secure. This also involves end-user capabilities like desktop, mobile equipment and other productivity tools for hybrid meetings. This project aims to enhance and modernize the infrastructure, networks and end-user equipment and productivity tools. The implementation rate in 2022 is limited to the funds that were made available for this purpose. The remaining work in this initial phase is planned for completion in 2023. The 2024-2025 budget considers further modernization/enhancement of secretariat IT infrastructure and equipment to address evolving users demands. The 2024-2025 biennium also considers purchasing IT licenses that follow a 3-year cycle that is due in that biennium.

10. Request: Core should never fund not mandated activities.

> Response:

The core budget is solidly based on mandates and has category 1 and category 2 activities.

Core budget includes category 1 and category 2 activities as proposed in our actual needs scenario. As this, scenario was almost double the current biennium budget, the secretariat has proposed a scenario that include category 1 activities and some category two activities as the proposed budget.

11. Request: Accountability of non-party stakeholders should be removed entirely from core budget. Response Measure should be in the core budget.

> Response:

The proposed core budget does not contain funds related to the recognition and accountability of non-Party climate action. All proposed funding related to such activities are contained in category 4, supplementary project SB300-006.

In terms of Response Measures, staff, non staff, including constituted bodies, costs, are within core. Other activities and costs are currently in category 2 and category 4, The financial and post impacts of moving costs and related outputs from supplementary to core are as follows:

Currently Category 4 (1 P-2 staff resource and EUR 755,155 in non-staff costs):

- Facilitate development of tools and a training framework to enhance understanding of impacts of response measures and reporting
- Implementation of KCI communication and engagement strategy
- Capacity Building to facilitate development and use of tools and methodologies,
- Outreach and engagement with stakeholders to promote strategies and best practices for just transition

Currently Category 2 (EUR 37,652 in non-staff costs):
